COMMUNITY OUTREACH PROJECTS FOR 2010

The Fulton County Marshal's Department is deeply committed to serving the community. We have hosted several Marshal's Department charity basketball games in conjunction with other agencies and county departments in prior years. In August 2010 we joined other law enforcement agencies for a "National Night Out 2010", America's Night Out Against Crime and also hosted a Community Impact Day at the Forest Cove Apartment Complex at Thomasville Park in Atlanta. We have participated every year in the annual Martin Luther King Day festivities, taken part in "Career Day" at several of the Fulton County Schools, supported Easter Seals, "Walk with Me" fundraisers, active participants in the Reading Patrol Program held at the Stonewall Tell Elementary School and for the last 26 years we have worked closely with the Fraternal Order of Police "Cops for Kids". We have also participated regularly in various Red Cross Blood drive, as well as functions held by the Public Safety community such as the National Police Memorial. However, this year we decided to reach out even further in the community with our presence at a candlelight vigil for the PADV (Partner's Against Domestic Violence). We organized a canned goods competition with the Solicitor's General Office where we collected a combined total of 300 can goods/non-perishable items. The donated items went to St. Peter's Missionary Baptist Church (Food Bank) in Atlanta. We also extended our hands to 14 families in need by passing out Thanksgiving baskets and to end the year we adopted a family for Christmas (one of the recipients' of a Thanksgiving basket). Six of the Marshal's deputies volunteered in the Easter Seals "Walk with Me" community service event on Saturday April 17, 2010. The deputies provided traffic control and other assistance to walkers and volunteers during the event.

Easter Seals has been helping individuals with disabilities and special needs, and their families, live better lives for nearly 90 years. From childhood development centers to physical rehabilitation and job training for people with disabilities, Easter Seals offers a variety of services to help people with disabilities address life's challenges and achieve personal goals.

PADV (PARTNER'S AGAINST DOMESTIC VIOLENCE)

On Thursday, October 7th a few of the employees from the Marshal's department participated in the 10th annual Candlelight Vigil at the Martin Luther King, Jr. National Historic Site. We wanted to show our support for the victims of domestic violence as well as to help put an end to this violent behavior in the community. This year the event was co-hosted by the YWCA of Greater Atlanta, Fulton DA's Office Victim Services, Fulton Solicitor's Office Victim Services, and the Feminist Women's Health Center. As a department, we collected over 40 used cell phones, by collecting these used phones this organization will be able to get the phones changed to 911 emergency phones for some of the victims and also for those who come into the shelters.

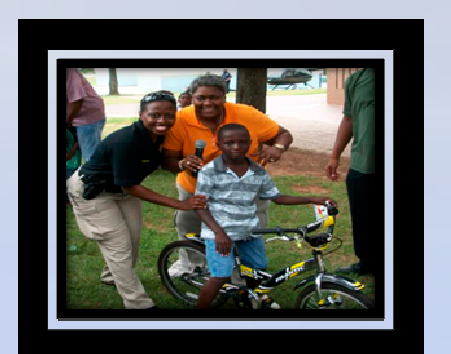

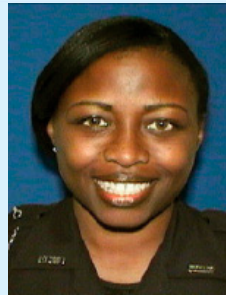

Congratulations are also in order for Captain K. Morton who attended the FBI Academy in July and graduated on Friday, September 17, 2010. The National Academy will be an experience and opportunity that he will never forget. The Marine Base at Quantico, Virginia is unique within itself. The base is large with many wooded trails that he had the privilege of running through. It was quite an eye opener for him to be running through the wooded trail and to hear large caliber guns blasting. As long as one stayed on the designated trail; no worries other than the bears, fox and ticks. But the National Academy had more to offer than that. The academics were another facet of the learning agenda as well. He was challenged in an environment that allowed him to be expressive but yet receptive to others views. Captain Morton was particularly interested in the way other countries established their judicial systems and how they were executed in comparison to our legal systems in the United States. Most countries had only one police agency that governed the entire country rather than several systems as we have here in the USA. There were 126 foreign countries, 6 federal agencies, 4 military agencies and 49 states represented. The total class consisted of 272 students. Captain Morton established new friendships during the 10 week training experience and was involved in interesting conversations relating to the same concerns and aspirations. The attitude and drive from the other students was so contagious that it motivated everyone. Captain Morton summed it all up by saying, "Being in an environment with others having the same goal was an awesome experience and the "Team" concept was displayed in a large and an exciting way."

The academy is an 11 week course which includes 16 written exams. Most exams require a minimum score of 70%. However, some exams require 80% and one requires a 90% to pass. Classes range from Constitutional Law to First Responder, First Aid, Firearms, EVOC and National Incident Management Systems. The more 'hands on' classes are Crime Scene Processing, Firearms and Emergency Vehicle Operation Course (EVOC). When the classes are a majority of Fulton County personnel, they will throw in a Code and Signal weekly test. During mandate preparation the cadets conduct map reading exercises to help them prepare for FTO.

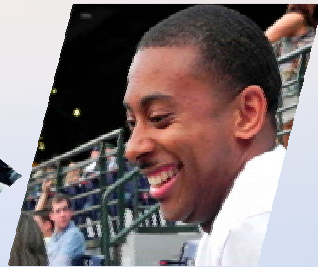
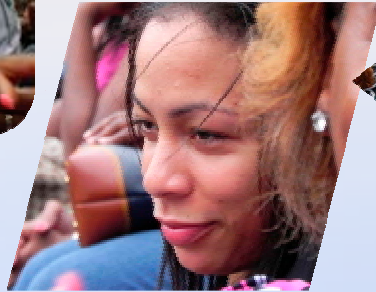
