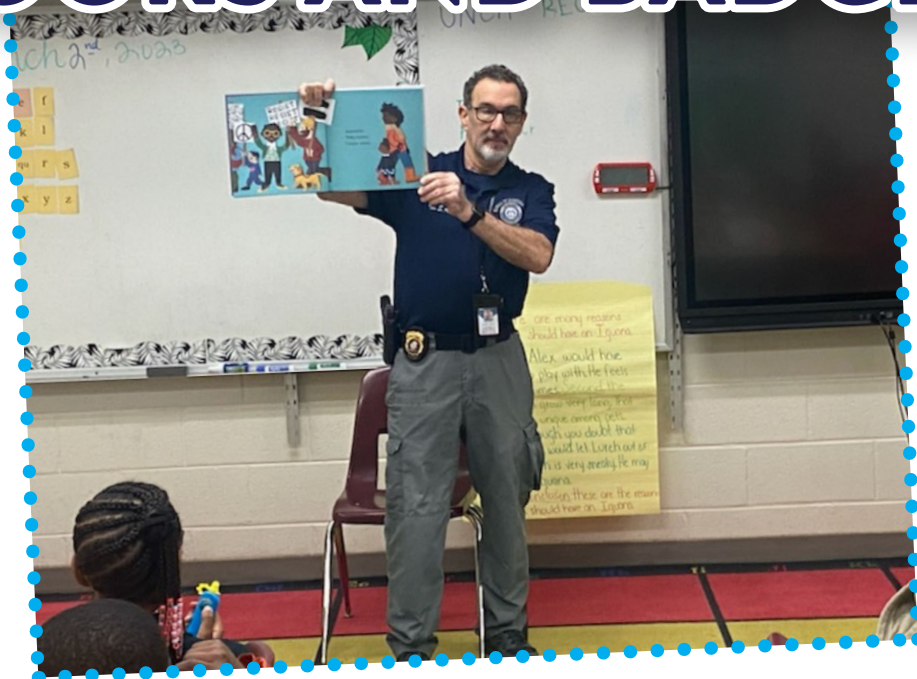

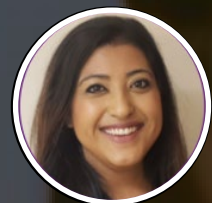
State v. Pedro Navarro-Zelaya

Women's HISTORY MONTH

Women's History Month began as a local celebration in Santa Rosa, California. The Education Task Force of the Sonoma County (California) Commission on the Status of Women planned and executed a "Women's History Week" celebration in 1978. The organizers selected the week of March 8 to correspond with International Women's Day. The movement spread across the country as other communities initiated their own Women's History Week celebrations the following year.

In 1980, a consortium of women's groups and historians—led by the National Women's History Project (now the National Women's History Alliance)—successfully lobbied for national recognition. In February 1980, President Jimmy Carter issued the first Presidential Proclamation declaring the Week of March 8th, 1980, as National Women's History Week.

Subsequent Presidents continued to proclaim a National Women's History Week in March until 1987 when Congress passed Public Law 100-9, designating March as "Women's History Month." Between 1988 and 1994, Congress passed additional resolutions requesting and authorizing the President to proclaim March of each year as Women's History Month. Since 1995, each President has issued an annual proclamation designating the month of March as "Women's History Month."

The National Women's History Alliance selects and publishes the yearly theme. The theme for 2023 is, "Celebrating Women Who Tell Our Stories," to honor women, past and present, who have been active in all forms of media and storytelling including print, radio, TV, stage, screen, blogs, podcasts, and more. The timely theme honors women in every community who have devoted their lives and talents to producing art, pursuing truth, and reflecting the human condition decade after decade.

RESIDUAL HEARSAY

If there's an out-of-court statement beneficial to you but the declarant is unavailable and the statement does not fall under a hearsay exception, you may have that statement admitted under O.C.G.A. §24-8-807: “[a] statement not specifically covered by any law but having equivalent circumstantial guarantees of trustworthiness shall not be excluded by the hearsay rule.”

However, to allow and admit the statement as permissible testimony, the trial court must determine the following three things per the statute:

1. The statement is offered as evidence of a material fact;
2. The statement is more probative on the point for which it is offered than any other evidence which the proponent can procure through reasonable efforts; and
3. The general purposes of the rules of evidence and the interests of justice will best be served by admission of the statement into evidence.

Once the court has found that the above-mentioned factors have been satisfied, it is within the court's discretion to allow the hearsay statement in the trial. Because the court is required to make these determinations, prosecutors need to know in advance about the statement because the court and the defendant need to be notified about the statement, its declarant, and the person who heard the statement.

The Georgia Supreme Court has said that Rule 807 applies only when there are certain guarantees of trustworthiness because such statement is considered sufficiently trustworthy due to the circumstances in which the statement was made. *Tanner v. State* 301 Ga. 852 (2017). Statements are considered “sufficiently trustworthy” not because of the credibility of the witness, but because of the circumstances the statement was made. *Smart v. State* 299 Ga. 414 (2016). That means we also need to know the nature of the relationship between the declarant and the hearsay witness. *Miller v. State*, 303 Ga. 1(2018).

I once had a witness who was the last person to see the victim alive and riding in the defendant's car before the victim went missing for a month prior to police finding his body decomposing in a ditch. The witness told the victim's best friend two days after the victim's disappearance about the victim riding away with the defendant. The witness unfortunately passed away and his potential testimony became hearsay. However, because the witness and the friend had a close relationship (she took care of him when he was sick, cooked for him, brought him home for dinner) in addition to the fact that the statement was made under circumstances where the friend were worried about the victim and looking for him, it had certain guarantees of trustworthiness - such that it would be admissible.

Self-Care and the Workplace

The World Health Organization defines self-care as “the ability of individuals, families, and communities to promote health, prevent disease, maintain health, and to cope with illness and disability with or without the support of a healthcare provider.” Self-care is important in this profession because we are exposed to various traumas from the experiences of our clients. In addition, working in the largest district attorney’s office in Georgia results in little downtime. Outside of work, we have personal lives that may make coming to work and being productive difficult. Furthermore, we have colleagues who may experience issues such as relationship and divorce, caring for loved ones who cannot care for themselves, financial constraints, mental health, physical health and disabilities.

Having a self-care regimen equips us with tools to deal with daily stressors and to stay resilient to serve victims and witnesses on a daily basis. A lack of self-care can hinder positive working relationships with our colleagues. There are different self-care assessments online, which I encourage you to take. If you score low, it may be time to consider other options for self-care.

Self-care is not a one-size-fits-all approach. For some, self-care is having a manicure and pedicure. For others, it may mean taking a vacation and relaxing on the beach; turning off the cell phone and ignoring everyone for a day; having lunch with a best friend to catch up on gossip; watching a movie with loved ones; exercising, meditating, or participating in spiritual and religious practices.

Self-care may include seeking professional assistance, such as counseling. Fulton County Employee Assistance Program is available to employees and provides up to 8 free confidential sessions.
