The following provisions are hereby made a part of this Request for Quote ("E-QUOTE"). Any contract or purchase order awarded as the result of this request shall be governed by these General Terms and Conditions. By submission of your responses to this e-quote, vendor agrees to furnish the product(s) and/or service(s) pursuant to these conditions.

1. **GENERAL.** These provisions are standard for all County contracts. The County may delete or modify any of these standard provisions for a particular contract or purchase order by indicating a change in the special instructions or provisions. **Any vendor accepting a purchase order award as the result of this request agrees that the provisions included within this Request for E-Quote shall prevail over any conflicting provision within any standard form contract of the vendor.**
2. **METHOD OF SOURCE SELECTION.** This procurement is being conducted in accordance with all applicable provisions of the Fulton County Code of Ordinances and the specific method of source selection for the services required in this bid is Code Section 102-373, Competitive Sealed Bidding.
3. **SUBMISSION OF RESPONSES.** Responses must be submitted for e-quotes on-line via the Vendor Self Service system at <https://fultonvendorservice.co.fulton.ga.us/webapp/VSSPROD/Advantage>. Response to e-quotes must be received no later than 2:00 p.m. on the date indicated.
4. **STATE OF GEORGIA IMMIGRATION REQUIREMENT.** Effective July 1, 2013, State law requires that all contracts for the physical performance of services for all labor or service contract(s) that exceed \$2,499.99 (except for services performed by an individual who is licensed pursuant to Title 26, Title 43, or the State Bar of Georgia) must comply with the Illegal Immigration Reform and Enforcement Act. 9. **BASIS OF AWARD.** The County shall award to the overall lowest responsible and responsive vendor complying with the provisions of the Request for E-Quote. 12. **BRAND NAME SPECIFICATIONS AND APPROVED EQUIVALENTS.** Unless otherwise specified, manufacturer's names, trade names, brand names, information and/or catalog numbers listed in the specifications are intended only to identify the quality and characteristics desired. They are not intended to limit competition. The Vendor may offer any equivalent product which meets or exceeds the specifications. 19. **LEGAL REQUIREMENTS.** Federal, State, County and local ordinances, rules and regulations, and policies shall govern development, submittal and evaluation of quote and disputes about quotes. Lack of knowledge by any Vendor about applicable law is not a defense.
20. **ASSIGNMENT.** Any purchase order awarded shall not be assignable by the Vendor without the express written approval of the County, and shall not become an asset in any bankruptcy, receivership or guardianship proceedings.
21. **REJECTION OF BID.** Bids may be considered irregular and may be rejected if they show omissions, alternations of form, additions not called for, conditions, limitations, unauthorized alternate bids or other irregularities of any kind. The County reserves the right to waive minor technicalities or irregularities of bid.
22. **TERMINATION.** In the event any of the provisions of the purchase order are violated, the County may serve written notice of its intention to terminate the purchase order. Such notice will state the reason(s) for such intention, and unless within ten (10) days after serving notice upon the contractor, such violation has ceased and satisfactory arrangements for correction made, the purchase order shall, upon expiration of ten (10) days, be terminated. Further, the County reserves the right to terminate for its convenience any purchase order in whole or in part upon giving thirty (30) days prior written notice to the other party.
23. **DEBARMENT.** If a Bidder is presently debarred, suspended, proposed for debarment, declared ineligible, or otherwise excluded from doing business with any government agency which prohibits your firm from participating in any procurement, the Bidder must provide the County with that information as part of its response to this solicitation. 24. **RIGHT TO PROTEST.** Any actual bidder or offeror that has submitted a bid/proposal for a particular procurement and is aggrieved in connection with the solicitation or award of the contract shall protest in writing to the purchasing agent after the date that the specific bid or proposal is submitted. No protest will be accepted or considered prior to the date the specific bid or proposal is submitted; it will be considered untimely. All protests shall set forth in full detail the factual and legal bases for the protest and specific relief sought by the protestor. The Fulton County Department of Purchasing is soliciting e-quotes from qualified bidders to provide development services for a Countywide **ADA SELF EVALUATION AND TRANSITION PLAN PHASE II REPORT** for the Office of Diversity and Civil Rights Compliance (DCRC), a Division of the County Managers Office. In this regard, the DCRC is specifically interested in the development of a final report of Phase II activities based on the changes and corrective action strategies the County has implemented to date as a result of findings in areas needing improvement identified by the Phase I ADA Self Evaluation Program Access Survey initiative and the resultant report (e.g. Full Access Ahead).

Vendor Responsibilities

- Vendor must develop a report that would document the changes/corrective action steps that Fulton County has implemented across departments since the issuance of the Phase I, Full Access Ahead Report, as well as identify those changes/corrective actions that are yet to be implemented.
- Vendor will base its report on a review of the completion status of approximately 928 corrective action plan (CAP) milestones divided among more than 30 departments, housed in the County's SharePoint site. The Vendor would be provided access to this site and/or data exported to an Excel file to form a foundation for its report highlighting those changes that have been made.
- Vendor will ensure that the Phase II Report is developed in a manner as to be consistent with the initial report that it was completed for Phase I of Fulton County's self-evaluation and transition plan.
- Vendor will conduct a thorough review of CAP milestones and center the subject report based upon the 8 focus areas contained in the *Full Access Ahead Report* (rather than by individual department). The 8 focus areas include the following: 1) infrastructure; 2) policies (reasonable modifications and eligibility criteria); 3)

communication; 4) furniture and equipment (including testing technology); 5) physical access; 6) transportation; 7) emergency procedures; and 8) outside entities.

- Vendor will be required to provide a detailed and comprehensive report to the county that addresses the following components:
 - Executive Summary;
 - Recap of Fulton County’s efforts leading to the Phase I Report, and its findings;
 - Discussion County’s response to Phase I Report findings; Improvements made;
 - Outstanding issues to be addressed and recommendations leading to next Steps.

- Vendor will be required to make an in-person presentation of the final Phase II report to the County Manager, Executive Staff, Department Directors and select other staff.

Fulton Responsibilities

Fulton County will provide the Vendor with access to the SharePoint site (and/or an exported Excel datasheet) housing the County’s program access CAP milestones as well as to any other data needed for review and analysis to support development of the Phase II Report.
