1. **Question:** The RFP specifies that we be reminded of the Fulton County "No Contact During Procurement" policy. Does this extend to community providers who may be county employees (such as the Health Department)?

2. **Question:** Will the members of the RFP evaluation committee be comprised of both County and Sheriff's office evaluators?

Answer: The members of the RFP evaluation committee will be comprised employees of Fulton County.

Answer: Staff is included in the staffing FTEs. Dialysis is provided by vendor, Chardonay, 256-362-1008.

7. **Question:** How and by whom is HIV testing currently being conducted on newly committed inmates?

Answer: HIV testing is being performed by the current vendor. Blood sample is processed by Bio-Reference Laboratory.

8. **Question:** Can you please provide current staff salaries?

Answer: Information is not available.

9. **Question:** Who is the current radiology provider utilized for x-ray interpretations?

Answer: Global Diagnostics

10. **Question:** What is the current JMS?

Answer: Odyssey

11. **Question:** Please provide the 2015 annual quantity of Tuberculin skin testing and Hep B vaccination series provided annually to Fulton County Jail staff?
