1. In Section 2, Bid Form, Page 3 of 5, on the Equipment Specifications and Installation Chart, change **NO SUBSTITUTIONS** to **SUBSTITUTIONS ARE ALLOWED**.
2. In Section 2, Bid Form, Page 3 of 5, Item #4 in the Equipment Specifications and Installation Chart, please change the part number from ULB9S-B to RLKULB9S-1-BB.
3. In Section 2, Bid Form, Page 4 of 5, Item# 27 of the Equipment Specifications and Installation Chart, change the quantity from 1 to 11.
4. In Section 2, Bid Form, Page 4 of 5, Item #28, a request for a price for shipping is being requested. There is a quantity of one (1) listed, as well as a column for Unit Price and Total Price. The quantity will remain at one (1), as the proponent will need to enter the total dollar amount for the shipment of all 11 vehicles as the unit price for shipping.
5. In Section 4, Scope of Work and Technical Specifications, Page 1 of 3, please add the following statement as item "e)" under the heading Vendor must:" All warranty repairs should be completed within forty-eight (48) hours of the initial diagnosis. The initial diagnosis should occur within twenty-four (24) hours of the vehicles delivery to vendor".





