*We have been using a free 60 day trial to LeadsOnline. LeadsOnline is the nation’s largest online investigative system used by law enforcement to solve crimes – from burglary and identity theft to homicide and narcotics. There is no equipment to maintain and no IT work required, detectives and reporting businesses simply access their respective LeadsOnline services via an encrypted password-protected connection from their browser. LeadsOnline maintains different information from Pawn Registries throughout Georgia and the U.S. (where thieves dispose of stolen items), Cellular Phone Kiosk across the Country (where thieves dispose of stolen phones), Metal Recyclers (where thieves dispose of stolen metals) and EBay/Craigslist (where thieves and other criminals utilize for disposal of stolen items). This one information system maintains all of this information and allows us access with their single website and we have not found another company that supplies the same investigative system.*

*In the first 15 minutes of the representative showing us how to use the free trial, we made four arrests for stolen items and located our Citizens property. They were very happy when we returned it to them. Giving the Police the tools to access information, identify suspects, locate stolen items and then return them to the citizens is what this is designed to do and it works.*
