What is considered a complete uniform by bid item number?

Answer # 1:

The uniform will consist of a 100 % polyester shirt short sleeve , 75% Polyester/25% Wool Blend shirt long sleeve, uniform polo shirt short sleeve, 100 % polyester trousers, 75% Dacron/25% Wool Blend trousers, six pocket uniform trousers, moisture wicking undershirt, socks, high gloss shoes, uniform athletic shoe, high top combat boot, MA-1 flight jacket, windbreaker, rain jacket, trouser belt, duty belt, holster, magazine holder, cuff case, 4 belt keepers, ANSI 107-2004 Class 2 traffic vest, body armor.
