**Page Two**

This Addendum forms a part of the contract documents and **modifies** the original RFP documents as noted below:

**The following questions were posed of the aforementioned ITB project:**

1. **QUESTION:** Can we post this bid on-line or does it need to be mailed?  
**ANSWER:** No, Fulton County does not accept electronic bids for ITB's; the bid must be delivered in person or via agent (i.e., FedEx, UPS, USPS, etc.).
  
2. **QUESTION:** On your bid for Uniforms & Gear – will it be awarded to a single vendor or will it be awarded to multiple vendors?  
**ANSWER:** This project will be awarded to Multiple Bidders.
  
3. **QUESTION:** On page 66 Item H – Tactical Illuminator – This is not on the Bid Pricing Sheet – what is the estimated quantity?  
**ANSWER:** The number for the Tactical Illuminator should be 25.
  
4. **QUESTION:** Will partial bids be accepted? We are an insignia manufacturer and are interested in the Badges, tie tacks and collar insignias.  
**ANSWER:** The County will accept partial bids for this project.
  
5. **QUESTION:** I request to either see the rainwear or be given manufacturer name and style number of the rainwear.  
**ANSWER:** Rainwear - Blauer, Defender 26991 Rain Jacket. The color is Black and yellow with grey stripping and Fulton /Sheriff. It is a Tech-lite. Deputies receive Blauer, Defender 26991 Rain Jacket, Black or Yellow, cut: J109142.

6. **QUESTION:** I would also like to request to either see or be given the dimensions of all emblems that are listed on the bid.

**ANSWER:** We don't know the dimension of the emblems but samples will be provided to the awarded vendor. Please see the attached pictures below.





7. **QUESTION:** Lastly, I would like to know if it is permissible to bid two manufacturers on some items. That is, I would like to bid the manufacturer requested on the bid, as well as an alternate manufacturer, essentially bidding two different manufacturers for the same item. If this is permissible, what is the correct way to enter this information?
- ANSWER:** We would ask that you bid on the appropriate brand name that is provided for you in the bid specification; however, the County will consider alternates as well.

8. **QUESTION:** On page 68, Section 7, Listed under shirts: Polo style (D/O Deputy Sheriff) Quantity 1257. Please provide brand name and style number, or detailed description.  
**ANSWER:** Polo style shirts for DO are heather grey color, short sleeve and long sleeve, 100% cotton.
9. **QUESTION:** On page 68, Section 7, Listed under Civilian Shirts: Khaki uniform trouser, quantity 700 Please provide brand name and style number, or detailed description.  
**ANSWER:** Civilian pants are khaki color, casual dress trouser pants, can be Lady Edwards or equivalent.
10. **QUESTION:** On page 68, Section 7, Listed under Civilian shirts: Khaki uniform shirt, quantity 50. Please provide brand name and style number, or detailed description.  
**ANSWER:** Civilian skirts (not shirts) are khaki color, 100% cotton 21" to 26" length.
11. **QUESTION:** The requested Nylok Pro duty gear (4200 series) has been discontinued. The bid is requesting no substitutions. Since the manufacturer no longer makes the requested items, will there be acceptance of substitutions?  
**ANSWER:** We will accept substitutions on all discontinued items with samples provided for approval.
12. **QUESTION:** Question on the rainwear, is the rainwear material gortex, PVC, etc. and is there any silk-screening?  
**ANSWER:** Rainwear - Blauer, Defender 26991 Rain Jacket. The color is Black and yellow with grey stripping and Fulton /Sheriff. It is a Tech-lite. Deputies receive Blauer, Defender 26991 Rain Jacket, Black or Yellow, cut: J109142.
13. **QUESTION:** The requested Taser holsters (519) series has been discontinued by the manufacturer. Will there be acceptions of substitutions?  
**ANSWER:** We will accept substitutions on all discontinued items with samples provided for approval.
14. **QUESTION:** I would like to verify under hats and accessories on the bid, it's calling for uniform caps, and on the specs there is (2) different kinds, BDU caps and Skull caps. Which one is going to be considered as the uniform cap?  
**ANSWER:** All caps will be considered; please provide prices on all caps that can be worn as outer wear.
15. **QUESTION:** Under the holster category you are requesting a hand gun holster, can you please advise as to which model gun and holster finish you are requesting?  
**ANSWER:** The handguns are mostly Glocks with various calibers. The finish is black basket weave and level III.
