1. Does the County furnish any administrative employees who are in the FLIC center or would we be responsible for staffing the entire office with both lawyers and admin/receptionist?

Response: The FLIC Office is currently staffed with three full-time Fulton County Superior Court employees. We will continue to staff this office.

2. Can you provide the pricing on the current contract?

Response: The current contract price is \$103,200 per year.

3. We currently have insurance that meets the requirements for all of the categories of insurance except for the professional liability. Our limits are currently \$500,000 per incident with a \$1,000,000 aggregate. Would that be sufficient? If not, could we bid for the contract with the stipulation that we would get the increased coverage if we are awarded the contract?
