**Questions submitted for clarification**

- Q. Is a Bid Bond required for the project?  
A. **Bid Bond, Payment and Performance Bond.**
- Q. Is the County responsible for obtaining D.O.T. permits?  
A. **Due to G.D.O.T. restrictions Fulton County will obtain encroachment permit.**
- Q. What type of information is required to be included with the pay applications for backup? Will a copy of the original work orders be sufficient?  
A. **Copy of original work or preferred DVD.**
- Q. Is it possible to be installing meters along GDOT Right of Ways? so, will the County consider adding bid items for lane closures or additional traffic control?  
A. **Yes, meters can be installed along GDOT, No additional bid items.**
- Q. Is a Utility Contractor's License required to bid the project?  
A. **Yes, Utility Contractors License is required.**
- Q. Is the contractor responsible for supplying all different sizes of copper that is required?  
A. **Yes, for all size copper.**
- Q. In the measurement and payment sections, it states that the contractor is responsible for all leaks for a period of 180 days after the installation. What limits as far as distance from the meter are we to be held responsible?  
A. **There are no limits, care must be exercised while working on and turning on water services.**
