Levi, Ray, & Shoup has been providing software licensing, as well as support and maintenance services, for their Pagecenter Software and the associated suite of LRS products including AFP Viewer, DRS, VPS/PCL, Report Browse, VPS/TCPIP, Pagecenter Web Access, and VPS.

Levi, Ray, & Shoup are the sole owner of the LRS Pagecenter application as well as the aforesaid suite of related applications. They own the software code and all rights to this software being utilized by Fulton County. The technical data for all the LRS products is proprietary. The licensing, maintenance, and support of these applications is only available through Levi, Ray, & Shoup.

Replacement of these applications with another product or vendor would result in extensive developmental and implementation effort, significant retraining expense, and significantly higher costs to Fulton County.

Levi, Ray, & Shoup has not licensed or otherwise given access to its proprietary code and data to any resellers or third party vendors.

These solutions are used by the Sheriff's Department and provide critical services, including the generation, printing, and management of mainframe based reports for the jail. If this item is not approved major functional processes of the County Jail will be negatively impacted.
