**Clarifications**

1. In addition to work described in Section 7, Scope of Work and Technical Specifications, 3,500 lf of steel shelving at the Auburn Avenue Research Library are a part of the General Collections Moving Services ITB. The mover will disassemble, pack and transport shelving from the 1<sup>st</sup> and 2<sup>nd</sup> Floors of AARL to the 1<sup>st</sup> Floor of Central Library, where it will be reassembled. At the end of the temporary move the Collections mover will perform the same task in the returning the shelving to AARL. Pricing for these services should be included in the Auburn Avenue Library bid.
2. Section 13, Exhibits, Exhibit III, Library Site Specifications, #8 Item a. Auburn Avenue Library (AARL), a portion of the 160,000 items given may not reside on book stack shelving.
3. Though Section 7, Scope of Work and Technical Specifications, Scope of Work, Item D., describes the types of items included in the Collections Moving Services ITB, the "microfilm/fiche cabinets housed on the 1<sup>st</sup> floor of Auburn Avenue Research Library are grouped with 40 4-drawer lateral files (including contents) and are not in this scope of work.
4. Section 9, General Conditions, General Requirements, Item C, Items which are designated as surplus property will be clearly marked or tagged and are the responsibility of the mover. When applicable, the bidder will pack, transport, deliver and place items in the Fulton County Warehouse, 79 Milton Avenue, Atlanta, GA 30315.
5. Replace Insurance Section 6, Insurance Information/Requirements , with the attached six provisions for each individual library branch.

- Question 1. Are all collections at all locations barcoded? If not, what percentage of material is barcoded?  
Answer: Yes.
- Question 2. Section 7, Paragraph E, Sub-paragraph C states "The Bidder shall be responsible for updating and maintaining an inventory list that travels with the collection, listing the contents, a detailed tracking system.." Can the library clarify how detailed the list of contents contained in the inventory must be?  
Answer : The Bidder shall be responsible for updating and maintaining details in the inventory list provided by Library Staff.
- Question 3. Section 7, Paragraph E, Sub-paragraph D states "The bidder will be responsible for delivering the collection to the new library based on tagged location". Will the tagging be broken down by class / subclass. For instance, non fiction by Dewey decade; Fiction by letter or range of letters? This will facilitate the efficient relocation of collections, especially larger collections such as the Auburn Avenue Research Library and the South Fulton Branch. This will also be important in those cases where the library will be interfiling opening day collections in order to leave adequate space for varying concentrations of material in different call number ranges.

Question 4. From the information collected at the tour of the Auburn Avenue Research Library it appears that there is not enough shelving on the first floor to accommodate all of the collections that are being relocated (specifically the collections that are located on the second floor compact shelving). In order to offset this, does the library plan to have some shelving in place at the temporary library prior to the move? If not, will the mover be required to move available shelving from another location and install it at the temporary library.

Answer: Specifically regarding the collections that are located on the second floor compact shelving at Auburn Avenue Research Library, yes, shelving will be in place at the temporary library prior to the move.

Question 5. Are all of the film cabinets located on the first level of the Auburn Avenue Research Library considered to be part of the collections relocation.

Answer: Refer Clarification #3.

Question 6. Form F refers to EEV / Basic Pilot Program. Is an EEV Basic Pilot Program User Identification number required?

Answer: Yes, it is an online process.

Question 7. At the Auburn Avenue branch, there was a large number of volumes that were not in the piece count to be moved to the temporary location. Has there been a determination as to where, and how these volumes are going to be moved and or stored?

Answer: The County can not provide a response to this question with out specific information.

Question 8. There is conflicting information about the submittal process, is this strictly going to be an online submittal or do we still have to submit paper copies as suggested in text of RFP? Or is it a combination of both?

Answer: This solicitation is an ITB, and section 1, Instructions to Bidders, shall be followed for this bid. All bids must be sent to the purchasing department.

Question 9. We note some move dates overlap and some are consecutive, are all the dates of the moves suggested meant to be consecutive?

Question 11: It has been noted that we are to bid on suggested linear footage, but we will only be paid for actual linear footage moved. Can you explain how you expect this scenario to work? How are you expecting to account for differences? What are the expected linear foot reductions? Because all of our costs (prep, measuring, mapping, travel, start up, etc.) needs to be included in the requested linear foot cost, and we are seeking to accurately account for this unusual request.

Answer: The lineal footage will be based on lineal foot of collections that exist in the library at the time of the move.

QUESTION 12: It is noted that the movers are responsible for tagging shelves, In Section 7, page 1, Item E it states that we are to remove items from existing tagged shelving. Can you explain what the 'existing tagged shelving' is/means?

Answer : The existing tagged shelving is related to the items that the mover is responsible for tagging as stated in SECTION 7, SCOPE OF WORK AND TECHNICAL SPECIFICATIONS, SCOPE OF WORK, E.

Contractor/Vendor will adequately protect its own work from damage, will protect Fulton County Government's property from damage or loss and will take all necessary precautions during the progress of the work to protect all persons and the property of others from damage or loss.

Contractor/Vendor shall take all necessary precautions for the safety of employees of the work and shall comply with all applicable provisions of the Federal, State and local safety laws and building codes to prevent accidents or injury to persons on, about, the premises where work is being performed.

Contractor/Vendor shall erect and properly maintain at all times as required by the conditions and progress of the work, all necessary safeguards for the protection of its employees, Fulton County Government employees and the public and shall post all applicable signage and other warning devices to protect against potential hazards for the work being performed.

**INDEMNIFICATION AND HOLD HARMLESS AGREEMENT**

To the fullest extent permitted by Law, Contractor/Vendor hereby agrees to release, indemnify, defend and hold harmless Fulton County, its Commissioners, officers, employees, subcontractors, successors, assigns and agents, from and against any and all losses (including death), claims, damages, liabilities, costs and expenses (including but not limited to all actions, proceedings, or investigations in respect thereof and any costs of judgments, settlements, court costs, attorney's fees or expenses, regardless of the outcome of any such action, proceeding, or investigation), caused by, relating to, based upon or arising out of any act or omission by Contractor/Vendor, its directors, officers, employees, subcontractors, successors, assigns or agents, or otherwise in connection (directly or indirectly) with its acceptance, or the performance, or nonperformance, of its obligations under these agreements. Such obligations shall not be construed to negate, abridge or otherwise reduce any other rights or obligations of indemnity which would otherwise exist as to any party or person as set forth in this paragraph.

Contractor/Vendor further agrees to protect, defend, indemnify and hold harmless Fulton County, its Commissioners, officers, employees, subcontractors, successors, assigns and agents from and against any and all claims or liability for compensation under the Worker's Compensation Act, Disability Benefits Act, or any other employee benefits act arising out of injuries sustained by any employees of Contractor/Vendor. These indemnities shall not be limited by reason of the listing of any insurance coverage.
