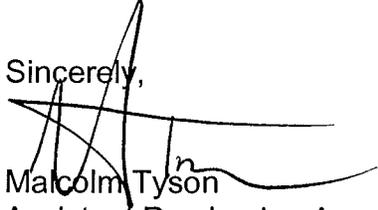

This Addendum forms a part of the contract documents and **modifies** the original RFP documents as noted below:

1. Addendum No. 2 is simply adding Wolf Creek Amphitheater & Skyboxes and the Event Staff required supporting each event to the existing contract. It does not specify removing or adding the Day Porter Services for the Public Safety Training Center because it already exists on the present ITB. Everything contractually pertaining to Group F—Other Offices South remains the same to include the Day Porter Service for Public Safety Training Center.
2. The new pricing page is for the initial term only because the Wolf Creek Amphitheater & Skyboxes is in the pilot stage. We will assess the performance of the selected Wolf Creek Vendor and determine if it's feasible to offer a 1st & 2nd renewal option. The 1st & 2nd renewal options remain for the other facilities listed in Group F in accordance with the ITB. To make matters easy, complete the Group F Pricing Sheets in the ITB and the Addendum Group F Pricing Sheet. If you have already listed your pricing for the other four (4) facilities (i.e. Public Safety, Transport, Community, Clubhouse, etc.) on the ITB Group F Pricing Sheet, there will be no need to list them again on the Addendum Group F Pricing Sheet. Just simply give the cost for the Wolf Creek Amphitheater & Skyboxes and the Event Staff cost and submit both Pricing Sheets with your ITB.
3. The Wolf Creek Amphitheater Events are seasonal and will require cleaning after each scheduled event along with contractual periodic cleaning (i.e. floors, carpet, etc).
4. We are simply asking for the hourly cost for 160 hours of Event Staff Support. The amount of personnel support can vary from time to time depending on the audience. It may require 15 personnel for this week's event and the following week it requires 20 personnel. The selected Vendor will know the estimated attendance prior to the event.
