**The following questions were posed of the aforementioned ITB solicitation document.**

**QUESTION 1:** On the Cadet Sweatshirt, will there be any silk screening or embroidered logo for this item?

**ANSWER 1:** There won't be any embroidery or silk screening on any sweatshirts.

**QUESTION 2:** On the ladies polo's and maternity smocks, will there be any embroidered logos for this item?

**ANSWER 2:** The ladies polo's will be embroidered with the logo and their name. The maternity smocks will be embroidered with FULTON COUNTY on the left side.

**QUESTION 3:** On the duty jackets will there be any embroidered names on these jackets?

**ANSWER 3:** No name on Jackets.

**QUESTION 4:** On the sweaters, will it require embroidered nametapes?

**ANSWER 4:** No nametapes on sweaters.

**QUESTION 5:** On the skull cap, will the department logo or initials be embroidered onto the hat?

Please specify whether these are dress khakis and a dress uniform shirt or if these are the poly/wool uniform trousers and shirts?
