Question: *Does the current vendor supply before & after pictures to you?*

Answer: *There is no specific schedule at this time.*

Question: *What type of hoods are installed at each location?*

Question: *Do you know the number of hoods and fans for each location?*

Answer: *There is one hood and one fan at each location.*

Question: *Are there diagrams of hood systems available?*

Answer: *Some Diagrams are available but not all.*

Question: *Are all the buildings stand-alone buildings?*

Answer: *Most building is single structured except some like Government Center, Juvenile Court etc.....*

Question: *Are they Single story buildings or are there multiple story buildings?*

Answer: *No*
