Questions:

1. Question: On page 58 the Velcro Underbelt Patent is calling for Safariland but the item number is calling for Boston Leather, directly under that you are asking for a basketweave Underbelt which Safariland makes, but again it has a Boston Leather number. Would you like to have a Boston Patent Leather belt quoted (6530-2)? The correct item number for the Safariland Basketweave underbelt item number will be 99-X-4.

Answer: Regarding the velcro underbelt Patent: please provide patent-leather underbelt for a dress uniform trouser as close to the specifications indicated. We prefer Safariland, if available. If Safariland brand not available, provide equivalent or better product.

2. Question: On page 57 item #752- Bates footgear is calling for Men's Light Weight Oxford Leather, but the Item number actually is the womens version of the shoe. Can you specify which Men's boot you are looking for, so that I may quote the correct one?

Answer: Regarding the Bates footwear item #752. This item number is an error. It should be Bates product number 112. We will edit our records to reflect update.

3. Question : On page 59, you have Safariland Item # 8321 listed for Open Double Handcuff Case, that number is not associated with Safariland. Is there another item # or vendor you may have associated with this product?

Answer: Regarding the open double handcuff case, if Safariland brand not available, provide equivalent or better product.
