Question:

Hi Cheryl,

Thank you for the opportunity to submit a bid response to this Bid. We are preparing our submittal and had a question in regards to:

Section 1, #1. Bid Preparation

Where it states that all dollar amounts must be BOTH in writing and figures. In section 4 (page 16) there is a blank line for the total dollar amount in figures and a blank line for the total dollar amount in words. However on page 17 the pricing chart with items 1-4 only has spaces for amounts in figures. Is it acceptable to list the amounts ONLY in figures on this page or should include a separate pages with those amounts written out? Can you please clarify if amounts in writing and figures applies to only the spaces at the bottom of page 16 or also to the chart on page 17 as well.

Thank you very much for your time and assistance.

Answer:

Page 15, and not 17, Section 4, "Base Bid Amount" should show the total dollar amount in figures and in words only and the total cost for lines 1 – 4 should be in figures only. This is the amount and in words that you will put on page 15, Base Bid Amount.

Do you have an estimated value or budget for the Fitness Equipment and Installation - Fulton County Project?
