The following changes are hereby made:

1. The due date has been changed from Thursday, August 27, 2015 to Thursday, September 3, 2015. The time remains the same as 11:00 AM legal prevailing time.
2. Changes are made to the following Section, Instructions to Bidders, General Terms and Conditions,

Page 3, No.4 Term of Contract is deleted in its entirety and replaced by the following:

#### **4. Term Of Contract**

The effective date of the Purchase Order shall begin the starting date and shall end absolutely and without further obligation on the part of the County on the 31<sup>st</sup> day of December 2016.

Page 5, No. 9 Basis of Award is deleted in its entirety and replaced by the following:

#### **9. Basis of Award**

The County shall award to the overall lowest responsive and responsible bidder complying with the provisions of the ITB - Commodities.

Page 6, **No. 13 Insurance and Risk Management Provisions and No. 14, Indemnification** are not required and therefore, deleted in their entirety.

3. Section 2, Bid Form Pricing Sheet(s) are deleted in their entirety and replaced by Attachment 1 under this addendum, titled the same.
4. Responses to Questions Submitted are included as Attachment 2 to this addendum.
