Answer: **For this RFQ you are only required to submit Exhibit “C” and an EBO Plan.** You do not have to submit Exhibit “D” at this time.

Question 2. Addendum 1, EXHIBIT C, middle of page 1 of 3, references an EXHIBIT F. Where would one find this form?

Answer: **For this RFQ you are only required to submit Exhibit “C” and an EBO Plan.** You don't have to submit Exhibit “F” at this time. If a joint venture it can be discussed in the EBO Plan.

Question 3. Reference above attachment to this email, “Fulton County’s EXHIBIT H, page 1”. While this document was not included nor referenced in the subject solicitation package, I found it available at the Fulton County Purchasing Web Site under AMS Advantage Vendor Self Service, etc., etc. A review of this attachment indicates there may be more forms that will need to be submitted as part of an EBO Plan. Please advise what Fulton County Forms, Contract Compliance and/or others, will constitute a complete responsible and responsive submittal at this initial phase of the solicitation process.
