This Addendum forms a part of the contract documents and **modifies** the original bid documents as noted below and answers questions asked by interested vendors:

1. **Question:** Can we submit bids for more than one tablet brand?
Answer: No. Only one bid is allowed per each vendor.

2. **Question:** One section of the Bid Request states that no bonds are required however, the "Bid Submittal Checklist" says that it must be submitted. Please verify if a Bid Bond is required for this request?
Answer: Bonds are not required for this project. Please disregard the Bid Bond section of the Bid Submittal Checklist.

3. **Question:** What duration of time is the County requesting to keep the evaluation unit?
Answer: If an evaluation unit is requested, the examination is expected to take no longer than 15 business days.

4. **Answer:** Will the evaluation unit be a basic evaluation or a permanent evaluation unit?
Answer: If requested by Fulton County, bidder must supply evaluation unit within 10 business days of the request. The evaluation unit must be exactly the same as unit being bid. The provided unit will then be returned upon completion of evaluation.

5. **Question:** Is the quantity of the evaluation unit one?
Answer: Yes

6. **Answer:** In terms of Inside Delivery, will this be delivery to one specific office or offices (in lieu of dock/warehouse delivery) or will it also include unpacking and set-up in specific offices/work stations?
Answer: Inside delivery will be to a specific office/suite. No unpacking or onsite installation by the vendor is required.
