#### Page Two

This Addendum forms a part of the contract documents and **modifies** the original Bid documents as noted below:

➤ Questions submitted for clarification:

- 1) Will the data/video streaming for the new 8 intersections be using the existing Ethernet network or this will be a new infrastructure as a part of Fulton TCC project?  
*This will be a new infrastructure that should be capable of integrating with the existing Navigator System.*
- 2) Does the Fulton TCC has already existing data management software/Rich Internet application (RIA) for analyzing/viewing traffic information or these need to be built ?  
*No, the system will need to be built*
- 3) Will the new system for the 8 intersections be required to use and conform to the same client applications/system software (mentioned under section 1.2, 3.0 (System software)?  
*Yes.*
- 4) Will the new system tie into the existing graphical interface suite of applications/widgets (outlined in Section 7.0 Graphical interface)? Or this will need to be developed as a part of the implementation?  
*The system will need to be developed and implemented.*
- 5) Who is the manufacturer of the equipment listed on the current scope of work and do they have an open API/SDK policy?  
*There are several manufacturers, the vendor need to contact them regarding their polices.*
- 6) Will the video information be stored locally at each intersection and will then be sent back to a central point at "off peak" hours?  
*The system should be capable of transmitting real time video.*
- 7) What will be the camera and storage requirements below for the system?
  - Resolution
  - Frames per second
  - Hours of activity
  - Percentage motion
  - Number of days of recorder video being kept*The vendor should propose this information. Cameras should at least meet ITE and IMSA standards and is currently used in similar situations.*
