**ORDER  
PROVIDING FOR APPOINTMENT  
OF MEMBERS TO THE  
FULTON COUNTY BOARD OF TAX ASSESSORS**

**WHEREAS**, O.C.G.A. § 48-5-290(b) authorizes the Board of Commissioners of Fulton County to appoint not less than three nor more than five members to the Fulton County Board of Tax Assessors; and

**WHEREAS**, O.C.G.A. § 48-5-290(c) provides that appointment of members to the Board of Tax Assessors shall be by Order of the Board of Commissioners regularly entered upon the record of the Fulton County Superior Court, and that a certificate of the Clerk of the Superior Court reciting the order and stating that the member has taken the oath required by law shall constitute the commission of a member of the Board of Tax Assessors; and

**WHEREAS**, the Fulton County Board of Tax Assessors presently has vacancies in all three of its member seats; and

**WHEREAS**, the Board of Commissioners finds that the Board of Tax Assessors shall better serve its mission as a five member Board whose members serve on a part-time basis; and

**WHEREAS**, the Board of Commissioners desires to appoint Pam Smith, Brady Barnett, Al Levine, Aubrey Osteen, and William Vinson as part-time members of the Fulton County Board of Tax Assessors.

**NOW, THEREFORE, BE IT ORDERED** that Pam Smith, Brady Barnett, Al Levine, Aubrey Osteen, and William Vinson are hereby appointed as part-time members of the Fulton County Board of Tax Assessors.

**BE IT FURTHER ORDERED** that Pam Smith, Brady Barnett, Al Levine, Aubrey Osteen, and William Vinson shall take office as part-time members of the Fulton County Board of Tax Assessors upon their presentation of a Certificate from the Clerk of the Superior Court of Fulton County reciting this Order and stating that they have taken the oath required by law.

**BE IT FURTHER ORDERED** that the terms of the said members of the Fulton County

1 Board of Tax Assessors shall be as provided by law.


2 **BE IT FURTHER ORDERED** that the Clerk shall forthwith transmit a certified copy of

6 execution.





**Chairman Skandalakis** - "All right. The Chair is prepared to entertain a motion for the appointment of five Tax Assessors, pursuant to the Board's previous action last week, which would be part-time versus full-time, and with those five part-time appointments there is also a salary structure set therein in the motion, and if the Clerk would announce that, I will so move unless another Commissioner wants to move. Okay. I will so make that motion."

**Commissioner Hightower** - "I second the motion."

**Chairman Skandalakis** - "And if the Clerk would read the names that we have selected, along with the salaries."

**Madam Clerk** - "The Board of Commissioners voted in Executive Session to appoint Pam Smith, Brady Barnett, Al Levin, Aubrey Osteen, and William Benson to serve as Tax Assessors at a salary of \$12,000 per year per assessor to serve the unexpired term of the former tax assessors, and they be sworn in immediately."

**Chairman Skandalakis** - "All those in favor? I'm sorry, did you give the salary?"

**Madam Clerk** - "Yes, \$12,000 per year."

**Commissioner Hightower** - "I'd also add that it was the intent of the Board, Mr. Chairman and members of the public, that these persons, Madam Attorney, will be sworn in immediately. I think it was the sense that I said no later than 5:00 p.m. on this Friday."

**Chairman Skandalakis** - "Is that part of the motion, is that acceptable to the Board?"

**Commissioner Fulton** - "Yes, it was, and I totally agree with that."

**Chairman Skandalakis** - "Can we display the vote? Okay. The next item, the Chair recognizes Commissioner Boxill for a motion."

A motion was made by Chairman Skandalakis and seconded by Commissioner Hightower to appoint the following five part-time Tax Assessors to serve the unexpired term of the former Tax Assessors at a salary of \$12,000 per year. The motion carried by a vote of 7-0-0.
