## QUALIFYING GUIDELINES PRIMARY ELECTION – MAY 21, 2024 & GENERAL ELECTION NOVEMBER 5, 2024

### I. CANDIDATES FOR STATE OFFICE

- A. Party Nominees for State Offices must qualify with the State Political Parties.
- B. Nonpartisan, Independent, and Political Body Candidates for State Offices must qualify at the State Elections Office, Suite 802, West Tower, 2 Martin Luther King, Jr., Dr. SE, Telephone number: (404) 656-2871.

### II. CANDIDATES FOR COUNTY OFFICE

- A. **Party Nominee:** Georgia Election Code, Section 21-2-153.  
Candidates for party nomination for county offices shall qualify by filing with:

- 1. **Democratic Party (Fulton County)**  
**Contact Democratic Party for location** (see page 3)

**OR**

- 2. **Republican Party (Fulton County)**  
**Contact Republican Party for location** (see page 3)

- B. **Nonpartisan/Independent/Political Body Candidates for County Office:**

- 3. File the Declaration of Intent (DOI) - if running for a new office and not an incumbent
- 4. File a Notice of Candidacy and Affidavit Form.
- 5. File the Affidavit of a Candidate's Intent Not to Exceed \$2,500 in Contributions and/or Expenditures (if applicable)
- 6. Pay the qualifying fee for the Office they are seeking (O.C.G.A. 21-2-131)

- **Personal Financial Disclosure Report** – due to Fulton County filing officer within 15 days of qualifying.

## PROSPECTIVE CANDIDATES FOR FULTON COUNTY SHERIFF

### **OCGA 15-16-1 Qualification Requirements for Sheriff**

OCGA §15-16-1, requires Sheriff candidates to be fingerprinted before qualifying for office. Each candidate for sheriff, whether current sitting sheriff or not, must have their fingerprints captured for each election cycle.

### **Fingerprinting Process**

Upon request of the candidate for sheriff, please complete the attached and provide us with a copy of documents.

The candidate for sheriff will then go to the sheriff's office and have their prints captured. It's important that they run the prints under the purpose code for "**OCGA 15-16-12 – Candidate for Sheriff**". The prints must be captured at the sheriff's office.

### **Please note:**

Such fingerprints are to be **taken prior to close of the third business day after the qualification period for Sheriff**. Such period shall begin upon the court's signature and shall run during normal business hours until **March 8, 2024**.

Monday-Thursday, March 4-7, 2024, at 9:00 a.m. to 4:00 p.m. and Friday, March 8, 2024, at 9:00 a.m.-12:00 p.m.





**Filing as Pauper:** O.C.C.A. §§ 21-2-153 (2), 21-2-132, 21-2-172, 21-2-187  
Candidates qualifying by pauper's affidavit:

1. File a Notice of Candidacy and Affidavit form
2. Check off on the form to file a Pauper's Affidavit
3. File a qualifying petition, signed by one percent (1%) of the total number of voters eligible to vote in the last election for filling of the Office for which the candidate is qualifying. To obtain the number of signatures required, please contact [elections.voterregistration@fultoncountyga.gov](mailto:elections.voterregistration@fultoncountyga.gov).
4. Pauper's affidavit, Notice of Candidacy, and Qualifying Petition must be filed at the time of qualifying. A qualifying petition may be circulated within 180 days of the last day the qualifying petition may be filed.
5. File the Affidavit of a Candidate's Intent Not to Exceed \$2,500 in Contributions and/or Expenditures (if applicable)

## **C. Independent Candidates and Political Body Candidates:**

Georgia Election Code 21-2-170 (a)(b)

An Independent or Political Body Candidate for County Office:

1. File a Notice of Candidacy and Affidavit between **9:00 AM to 4:00 PM. on March 4, 2024, through Noon, March 8, 2024, to have his / her name placed on the General Election ballot.**
2. Pay the required qualifying fee or file a Pauper's affidavit. If filing a pauper's affidavit, the candidate must also file a qualifying petition.
3. File a nomination petition with the Fulton County Elections Office, 5600 Campbellton Fairburn Road, Fairburn GA 30213, beginning **9:00 AM to 4:00 PM on June 24, 2024 through 9:00 AM to 12:00 PM on July 9, 2024.** See Code Section 21-21-132 (d).

The nomination petition must be signed by **five percent** (5%) of the registered voters eligible to vote in the last election for the filling of the Office the candidate is seeking. **Refer to the following chart for the number of signatures required.**
