

# GRIEVANCE REVIEW COMMITTEE

**Board Established by:** County

**Description:**

During the August 5, 1998 Regular Meeting (Item #98-1073), the Board of Commissioners voted to hire an attorney to represent and legally advise the Grievance Review Committee at all grievance proceedings. The attorney will also provide legal assistance when deemed necessary. This board was established by the Board of Commissioners at its Special Meeting on June 4, 1980, to review and make determinations regarding employee grievances, pursuant to Fulton County Procedure #100-24, in the County Procedures Manual. On September 19, 2018 (item# 18-0671) the Board of Commissioners approved a resolution authorizing an increase of a stipend to the community member of the Fulton County Grievance Review Committee in the amount of \$150 for each day that the member participates in hearings held by the Fulton County Grievance Review Committee.

**Membership/Appointment:**

Consists of five (5) members. Two (2) members are appointed by the County Manager from the Fulton County workforce for staggered two-year terms, with selection eligibility as follows: Management Personnel or Supervisory Personnel. Two (2) members are elected by a Countywide employee election for a two-year term. One (1) member from the general public is to be selected by the elected and appointed members of the Committee for a three-year term. (NOTE: EMPLOYEE GRIEVANCE PROCEDURE #100-24. Reference: Special Meeting, May 18, 1983, item #24.) For the appointments made by the Commission, the County Manager has customarily nominated persons to be appointed by the full Commission.

**Term:**

Two (2) members shall be appointed by the County Manager from the Fulton County workforce for staggered terms of two (2) years each, Two (2) members shall be elected by County-wide election. The term of office for such members shall be two (2) years. One (1) member shall be selected from the community by the Committee.

**Compensation:** YES                      **Stipend:** \$50/citizen \$150/Comm member
