Our 2022 accomplishments in the first quarter of service to the people of Fulton County

We are pleased to report on our progress in the first four months of 2022 through this report. As a candidate for District Attorney in 2020, I promised the voters of Fulton County that my office would be dedicated to making every neighborhood in our county safer, acting with integrity, and being honest and transparent with the public. This report is an important part of keeping those commitments.

We continue to face unprecedented challenges. The backlog created by the pandemic's shutdown of our judicial system is still with us, and the surge in violent crime in Fulton continues to add serious cases to the burdens facing this office, the police and the courts at a rapid rate.

We are pleased, however, that we have made great progress in improving our office and working with our partners in county government, law enforcement and the courts to make real progress in improving public safety. Thanks to the support of our county commission, 129 new positions in our office were authorized. We have aggressively worked to fill positions and have a vacancy rate under 8%. While doing that, we have been able to raise standards for experience in our new hires. We now require at least three years of practice experience for entry level attorneys. We have attracted highly experienced investigators, many of whom come to our office with 15 plus years of experience as police officers and detectives. We have been able to add investigators with significant government and private sector experience in using technology in investigations.

Our new Case Intake Division has greatly improved the office's building and indictment of cases, which will lead to better outcomes for victims and their families. The improved investigations by the Case Intake Division is also preventing the office from seeking indictments in cases that should never be brought, which was a problem in the prior administration.

We have added prosecutors and investigators to our Major Crimes Division to handle gang-related cases, murders, sexual assault and cold cases. Every prosecutor and investigator in office now receives training in recognizing gang-related cases, and how to best investigate and prosecute them.

Our Special Victims Division is working with police and prosecutors to ensure that human trafficking cases are recognized and prosecuted as such, and that human trafficking victims are recognized and offered support and assistance. We have created a unit that combines expertise in human trafficking and gangs to recognize and prosecute gang-related human trafficking, and we have brought the first RICO indictment related to human trafficking in Georgia history. We have also successfully expanded our Sexual Assault Kit Initiative Unit to find and prosecute cases from old, untested sexual assault kits through increased federal grant funding.

Our Trial Division has added experienced staff and is working with the Case Intake Division to move through cases more efficiently and effectively. We have ended the historic problem of cases being dismissed by judges in Non-Complex Unit of the Superior Court, due to failure of having evidence ready for discovery at indictment. Our Trial Division staff is now more experienced and better trained.

My administration has created a new Civil Rights Unit to handle cases involving allegations of physical abuse of citizens' by law enforcement officers. They are keeping my commitment to citizens and law enforcement agencies to make determinations on cases based on the facts and the law, and to not allow cases to languish in perpetuity.

Our newly created Anti-Corruption Unit is focused on cases involving allegations of wrongdoing by government officials, as well as cases involving allegations of election fraud. Prosecutors and investigators in the Civil Rights and Anti-Corruption Units have developed expertise in their specialized areas that allows them to handle cases fairly and efficiently.

We have worked with community partners to create ground-breaking diversion programs for both adults and juveniles. We can now divert or send cases to accountability court before indictment. We have partnered with the United States Attorney and the Fulton County Juvenile Court to bring the Credible Messengers program to at risk youth. Our Conviction Integrity Unit is fully functioning and reviewing convictions and sentences. To date, the unit has overturned both unjust convictions and modified unjust sentences.

We have made great progress, but we still have much to do. We thank you for your support and your partnership as we work together to make Fulton County a safer, more just place for everyone.

What We Have Accomplished

Our Top 5 Accomplishments

- **1.** Trained all lawyers, investigators and Victim Witness staff on Implicit Bias.
- **2.** Created the first LCBTQ plus advisory committee in a District Attorney's Office in the South East.
- **3.** Partnered with Mayor Andre Dickens of Atlanta, the Atlanta Police Foundation, the Atlanta Police Department and the Fulton County Sherriff's Office to create a Repeat Offender Tracking Unit.
- **4.** Created a Community Resource Specialist Unit to interface directly with the community on issues involving crime that impact their quadrant of the county.
- **5.** Created with our Criminal Justice Partners a Child Abuse Protocal to ensure all agencies involved with protecting children use the best practices.

Human Trafficking and Child Exploitation Unit

- 6. Hosted the first Human Trafficking awareness forum with over 450 participants.
- **7.** All members of the Human Trafficking Unit attended child exploitation /internet crimes training.
- Provided education and awarness training at the National Coalition of 100 Black Women, Metropolitan Atlanta Chapter and Stone Mountain Chapters.
- **9.** Indicted first Human Trafficking case involving violations of the Georgia RICO Act in the history of Fulton County.
- **10.** All Human Trafficking Investigators trained with the FBI/GBI Violent Criminal Apprehension Program.
- **11.** Indicted 8 cases of Internet child exploitation in which 75 children were sexually abused and depicted in child pornography .

Juvenile Unit - 100% Conviction Rate

- **12.** Spoke to over 100 students at 5 Fulton County public schools about citizenship, truancy and gangs.
- **13.** Started a juvenile intervention initiative at the @promise center to provide safe positive programs for children as an alternative to gangs.
- 14. Implemented a intervention initiative to match juveniles charged with delinquent offenses with a certified "credible messenger" mentor.
- **15.** Coordinated with court administration to begin the Ascend program for serious juvenile offenders. The Ascend program provides youth one last chance to aviod prision.
- **16.** Started specialized gang prosecutions of juvenile offenders who are active gangang leaders.
- **17.** Began a juvenile intervention tracking program to ensure juveniles attend their intervention meetings and have transportation.
- **18.** Participated in District 4 Commissioner Natalie Hall's Empowering Young Men Summit. Through this Summit FultonCounty District Attorney's Office spoke to over 300 children about making good decisions.

Sexual Assault Unit - 100% Conviction Rate

- **19.** Trained South Fulton seniors on how to avoid becoming sexual assault victims.
- **20.** Collaborated with Georgia Tech to provide information to Sexual Assualt and Domestic Violence victims.
- **21.** Participated in career day at Thomasville Heights Elementary.
- **22.** Met with leaders Fulton County hospitals to discuss the best practices in serving victims of sexual assault.
- **23.** Began utilizing the cutting edge science of forensic genetic genealogy to begin solving cold case sexual assaults.
- 24. Entered 21 cases in to the Violent Crime Apprehension Program (ViCAP) database, resulting in searchable cases for law enforcement agencies across the nation, bringing our overall sexual assault cases in ViCAP to 83, surpassing any other agency in Fulton County, and the second most sexual assault cases entered by any agency in the state. While other agencies began this process more than 20 years ago, Fulton County District Attorney's Office SAKI has ac complished this in one year.

Terrell Williams Crimes Against Children Unit - 100% Conviction Rate

- **25.** Successfully tried 4 felony trials to verdicrt, bringing justice to 8 child victims.
- **26.** Completed the 2022 Fulton County Child Abuse Protocol in conjuiction with our law enforcement partners. The Fulton County Child Abuse Panel hadn't been updated since 2015.
- **27.** Collaborated with Atlanta Police Department to begin a formal roundtable process of all cases involving child victims.
- **28.** Completed the Zero Child Abuse Project training for forensic interviewers and prosecutors.
- **29.** Reduced unindicted backlog caseload by 50%.

Conviction Integrity Unit

30. Developed, established and swore in the Conviction Integrity Unit Review Committee.

Brenda Baham Domestic Violence Unit - 100% Conviction Rate

- **31.** Successfully tried 3 Domestic Violence cases, 2 of the cases where homicides. All 3 defedants were convicted, bringing justice to 3 heartbroken families.
- **32.** Trained Atlanta police officers on proper report writing in Domestic Violence cases.
- **33.** Trained Fulton County Officers on best practices for documenting and collecting evidence in strangultion cases.
- **34.** Trained all Fulton County District Attorney's office investigators and attorneys on providing victims with resources to obtain temporary protective orders.
- 35. Resolved over 100 Intimate Partner violence cases.
- **36.** Spoke to students at Bear Creek Middle School about making better choices to aviod becoming defendants in the Criminal Justice System.

Elder Abuse and Animal Cruelty Unit

- **37.** All Lawyers certified as ACT (At-Risk Adult Crime Tactics) Specialist.
- **38.** Expanded our partnership with Canine Cellmates to include private businesses, offering employment to qualified participants. This program offers rehabiliative services and job skills to defendenants, offering a better chance at success.
- **39.** Assisted out-of-state ploice agency identifing and capturing a murder/animal cruelty deffendant.

Gang Unit - 100% Conviction Rate

- **41.** Developed a task force between the Atlanta Police Department and Fulton County District Attorney's Office investigators involving juvenile defendants.
- **42.** Successfully tried 3 gang cases with 5 gang members gaining extensive sentences.
- **43.** Participated in a joint operation within the Fulton County Jail with the Fulton County Sheriff's Office to successfully seize dangerous contraband inside the jail from gang members.
- **44.** Created a partnership between Fulton County Sheriff's Office and the Fulton County District Attorney's Office to encourage information sharing in gang cases.
- **45.** Established an intake/first appearance protocol with the Atlanta Police Department Gang Unit to insure the effective handling of gang cases once arrests are made.
- **46.** Taught Gang Investigations to law enforcement officers around the State of Georgia.
- 47. Trained 50 plus new law enforcement officers on courtroom demeanour.
- 48. Responded to all gang related homicide scenes to assist in investigation.

Civil Forfeiture Unit

- 53. Received for forfeiture \$569,938.54 seized property form criminals.
- **54.** Provided **\$506,005.49** to arresting agencies from seized proceeds to use for crime fighting resources.
- **55.** 84 notices of seizure filed.
- **56.** 10 complaints for forfeiture filed.
- 57. Obtained final orders and dispositions in 75 cases.
- **58**. Obtained partial judgments & dispositions in **27 cases**; regarding the partial judgments, closed on the currency and are waiting on the associated criminal case to resolve in order to forfeit the seized firearms.

Major Case Unit - 88% Conviction Rate

- **59.** Developed and implemented pre-trial motion protocols to assist in effective prosecution of cases.
- **60.** Assistant District attorneys and Investigators reported to 90% of all homicide scenes in the city of Atlanta to provide legal assistance when requested to Atlanta Police Officers.

Appeals Unit

- **61.98%** appellate success rate for cases in the entire office.
- 62. Over 20 Direct Appeals Affirmed.
- 63. Successfully argued 4 cases before the Georgia Supreme Court.

White Collar Crime Unit

- 64. Completed resolution of backlog of all 2020 pre-indictment cases.
- **65.** All White Collar Crime Unit members completed additional training on money laundering, intellectual property theft, spreadsheet skills, financial records analysis, and other topics through local agencies and through the National White Collar Crime Center.

Trial Division

- 66. Complex Legal Asistant have closed out over 3100 case files.
- 67. Complex Asistant District Attorneys have closed in excess of 100 cases.
- 68. Successfully closed over 300 cases since January 1, 2022.

Case Intake Division

- 69. The Case Intake Division has indicted accused in excess of 2,000 cases.
- 70. Indicted 43 homicides cases in 2022.
- **71.** Indicted 51 defendents for homicide in 2022.
- **72.** Created a mini unit that includes 3 investigators, 5 attorneys and 1 legal assistants within the Case Intake Division that specialize in cases involving Crimes Against Children, Adult Sexual Assault and Domestic Violence.
- **73.** Partnered with Mayor Andre Dickens' office to create a repeat offender tracking unit.
- 74. Trained 6 law-enforcement agencies on case-intake procedures.

Open Records Unit

75. Processed and closed a total of 175 open records as of April 2022.

Investigations Division

Investigations Division

- **76.** 5 investigators have obtained creditials to become certified teachers for the Investigative Division.
- **77.** Investigators have completed 90% of required training hours for 2022.

Evidence Unit

- **78.** Initiated a process for handing appeals evidence between the court reporters and the Fulton County District Attorney's Office creating a written chain of custody for all evidence transfers.
- **79.** All unit employee's attended evidence training through the International Association of Property and Evidence for a better knowledge of evidence handling and storage.

Justice Liaison Unit

- **80.** Completed evaluation of Futon County Sheriff's Office as required by law for the first time in over two decades.
- **81.** Coordinated and implemented the Futon County Grand Jury Inspection of the Futon County Tax Commissioner Office as required by law.
- **82.** Secured a \$50,000 Grant for Formulytics Software that will assist in prosecution of dangerous gang members.
- **83.** Published the Grand Jury Presentment Reports regarding the inspection of the Fulton County Tax Commissioner's Office, the Fulton County District Attorney's Office, the Fulton County Probate Court, the Office of the Fulton County Clerks of Superior Court, and the Fulton County Jail. Inspections nor reports have been completed in over 2 decades.

Investigations Division

Digital Technology Unit

- **85.** Completed 49 cellular extractions providing valuable evidence to the prosecution of dangerous criminals.
- **86.** Became a member agency with the US Secret Service and Atlanta Cyber Fraud Task Force.
- **87.** Conducted over 100 consultations on digital forensics, technology, and threat assessment best practices.
- **88.** Built relationships and formal intelligence sharing plan with the Federal Bureau of Investigation and Georgia Bureau of Investigation.



- **89.** 100 participants have been enrolled in Pre-Indict Diversion for non-violent offenses. Pre-Indictment Diversion provides defendants life skills, mental health assessments, job training and record restriction. Pre-Indict Diversion provides partipants with a second chance to be productive members of the community.
- **90.** All Pre-Indictment Diversion staff was trained and MRT certified to facilitate the Adult Diversion courses.

Records Unit

91. In the first quarter of 2022 the Records Unit closed in excess of 500 cases.

Record Restriction Unit

92. Increased efficiency of the Grand Jury work up process by 95%.

Civil Rights Unit

- **93.** Attended a briefing with the members of the Atlanta Pplice Department's Fugitive Unit to discuss legal parameters as well address concerns and issues of their Unit regarding the serving of warrants.
- **94.** Appointed a liaison responsible for assisting the APD Fugitive Investigators when they are faced with questions or incidents where additional guidance is needed.
- 95. The Civil Rights Unit Investigators earned 184 hours of specialized training.
- 96. Determinations made in 10 cases involving allegations of police brutality.
- **97.** Met with Atlanta Police Chief Rodney Bryant and Training Academy Director Fred Watson to implement training for the entire Department on Gun Safety, Gun Handling, including transportation, storage and firing in defensive situations.



- **98.** Developed and implemented protocol and processes for the newly formed Anti-Corruption Unit.
- **99.** Members of the Anti-Corruption Unit have attended a total of 224 hours of specialized training to include, Gangs, Impaired Drivers, Use of Force, Internal Affairs, Voir Dire, and Trial Tactics.



Grants Unit

- **100.** Obatined the Hate Crime Grant for the Fulton County District Attorney's Office. This grant is the only one in the South East to focus on the LGBTQ plus communities special needs as crime victims. The grant is used to educate both the Fulton County District Attorney's Office employees as well as our law enforcement partners on best practices.
- **101.** Received a gang focused grant that allows us to focus on hot spots in the county for gang activity by contributing resources for a Gang Investigator and a Gang Assistant District Attorney.
- **102.** Received a grant that will allow us to provide mentoring services to children living in gang hot spots in our county.
- **103.** Received a grant to hire a social worker that will connect families with mental health assistance that live in underserved communities.
- **104.** Obtained a cold case grant that will allow our office to hire experts that will focus on aged homicides throughout the 15 municipalities.
- **105.** Obtained a grant that will provide all Fulton County District Attorney's Office investigators deescaltation training tools.

Programs Division

- **106.** Fulton County District Attorney Willis hosted two North Fulton Faith Based meeting to discuss the intersection of youth and trafficking and gang involvement and how Churches can offer counseling and mentorship programs to help prevent crime and be involved with the community.
- **107.** Fulton County District Attorney Willis hosted a North Fulton Elected officials update to discuss public safety and tools to keep crime rates down.
- **108.** Develop Youth Anti-Gang Community Coalitions to identify and create solutions to provide more resources to youth at risk for being recruited into gangs.
- **109.** Develop Anti-Gang youth Questionnaire to collect and quantify grassroots level ideas for combatting gangs.

Victim Witness Advocate Unit

- **110.** Developed and implemented a training class for advocates to ensure they properly serve all of Fulton County's victims.
- 111. Cleared the backlog of U-Visas.
- 112. Provided over 2,000 service units.
- **113.** Provided services to over 700 crime victims.
