The September 18th meeting of the Planning Council was called to order at 9:02 a.m. by Chair, Dazon Dixon Diallo. Quorum was established and the meeting started with introductions from 2014 – 2015 Planning Council members.

Fulton County Chairman, John Eaves was present to seat the new Planning Council and thanked the Planning Council along with the Ryan White Part A Staff for all the work that everyone is doing in the Community.

Chair, Dazon Dixon Diallo provided a brief overview of the purpose the Planning Council.

The Chair then moved to approval of the agenda.

A motion was made by Katherine Lovell and seconded by Jeff Graham to adopt the September 18, 2014 agenda. The motion carried.

A motion was made by Timothy Webb and seconded by Terry Stidom to adopt the August 20, 2014 Planning Council minutes.

Consumer Caucus Update: Timothy Webb – Chair of Consumer Caucus

- The Caucus met on Wednesday, September 17th at AID Atlanta. The Caucus meets every third Wednesday before each Planning.
- The Caucus is in the process of electing a co-chair.
- There are (2) two HIV AIDS Conferences Positive Living in Fort Walton, Florida and USCA in San Francisco, California.

AAOI Update: Freda Jones - Chair of the Atlanta Area Outreach Initiative

• An update was provided on the status of AAOI plans as well as an appeal for agencies to participate by referring newly diagnosed individuals to the event.

Grantee Update: Patrick Daly – Director, Ryan White Part A (Grantee)

- The Grantee reminded the Committee that the HRSA FY2015 Grant Application is due by Friday, September 19th. The Grantee would like to submit the final application on Wednesday, September 17th. The Grantee is also working on compiling information requested by Commissioner Darnell at the last Board of Commissioners meeting (BOC).
- Residual Applications were due Wednesday, August 20th. Thirteen (13) agencies applied for additional dollars. The Grantee was able to award all thirteen applicants. A total of \$115,431.09 (\$7,880 from Residual and \$107,550.86 from Projected Carry Over) remained un-awarded and added to the State ADAP category. The majority of these funds are from the projected carry-over request which has not yet been awarded.

Council Procedures: Larry Lehman – Council Procedures Chair

- The Council Procedures Committee has completed their final review of the Planning Council By-Laws.
- There will a thirty day comment period on the Planning Council By-laws.

- All comments are due by Friday, October 17th.
- The Council will vote on the By-Laws at the November Planning Council meeting.

Committee Updates:

Assessment Committee: Steven Bales - The Assessment Committee is working with SEATEC on the 2014 Consumer Survey. The Committee meets on the 1^{st} Wednesday of every month at Positive Impact from 9:30 a.m. -11:30 a.m.

Comprehensive Planning Committee: Katherine Lovell – The Comprehensive Planning Committee is working on completing the 2014 Comprehensive Plan Work Plan. The Comprehensive Planning Committee meets on the 2nd Wednesday of every month. The next meeting will be held Wednesday, November 13th at Grady IDP room 341 from 9:30 a.m. – 12:00 p.m.

Council Producers Committee: Larry Lehman – The Council Producers Committee will meet in November.

There were ninety-five (95) applications submitted and 55 voting members are being seated. New Membership Orientation will be on Friday, October 10th at the Loudermilk Center from 9:00 a.m. – 2:00 p.m. The Leadership Institute Training planning session will be held on Monday, October 21st from 10:00 a.m. – 2:00 p.m. at the Ryan White Office.

Public Policy Committee: Jeff Graham – The Public Policy Committee reviews the public policies on the local, regional, state and federal level and advises the members of the Planning Council of Potential impact of legislation which may affect the Ryan White Program. Jeff Graham informed the Planning Council of voter registration dates; the deadline is Monday, October 6th. The Planning Council was also informed of AIDS WALK on Sunday, October 19th.

Priorities Committee: Dazon Dixon Diallo – In the absence of a Priority Committee Chair Dazon Dixon Diallo provided an overview of the duties of the Priorities Committee whose responsibilities include assessing the services needs and recommends priority rankings and funding percentages for allocation of funds.
