PREPARATION FOR ELECTION / WORK SUMMARY:	

We have completed the draft 2026 Elections and Operating budget. The Elections budget for 2026 includes four election cycles. The draft 2026 budgets were submitted to the Finance department for further review by the Fulton County budget committee. The draft budget for 2026 is noted below.

The Fulton County Board of Commissioners (BOC) approved the 2025 Elections budget for a total of \$15 Million which included funding for the four PSC/Municipal elections. The approved 2025 Operating budget is \$5.4 Million.

The Financial Systems manager has continued to update the 2025 budget reporting. We have updated the budgets for the July 15, 2025, PSC Primary run-off election. We have prepared a budget for the August 26, 2025, Special called election for State Senate 21 and for the special run-off election on September 23, 2025.

We are also processing the vendor invoices for expenses incurred for 2025 elections work.

We continue to review the budget to actual costs for the 2025 Election cycles. We are generating both the Accounting and Purchase order reports to review our costs and to stay within our budget.

PREPARATION FOR ELECTION / WORK SUMMARY:

This Monthly Report summarizes key registration activities, workload levels, and voter registration statistics for the Registration Division of the Fulton County Registration & Elections Department for August 2025. Throughout the month, the VR staff focused on processing voter cancellation requests, conducting allowed list maintenance activities in the Georgia Registered Voter Information System (GARViS) due to the July 28th cutoff period for the State Senate District 21 election, and continuously auditing the voter roll. Additionally, the Registration Division provided support to Advance Voting and election day poll workers and voters and handled all post-election responsibilities which included processing provisional ballots and completing retention responsibilities.

DATE OF REPORT: August 31, 2025

PREPARATION FOR ELECTION / WORK SUMMARY:

In August, the Voter Education and Outreach team focused on promoting the Senate District 21 Special Election across the county. They attended various events in different cities to ensure residents were informed about the upcoming elections.

The VEO Manager stays informed and participates in all sessions of the GA House of Representatives Blue-Ribbon Study Committee on elections, providing updates about proposed legislation affecting elections next year to the Leadership team. The next meeting is scheduled to be held in Savannah, Georgia, on Thursday, September 18, 2025. The VEO Manager also continues to monitor all GA Election Board meetings.

The VEO Manager conducted Deputy Registrar Training for Fulton County School administrators to keep them updated on laws and election procedures for 2025, enabling them to host voter registration drives at their schools. The VEO team is working with Atlanta Public Schools and Fulton County Schools to participate in open house and back-to-school events where voter education and registration support are needed. The VEO Manager sent out letters to each Fulton County high school and senior centers within the county regarding

third-party organizations conducting voter registration drives, as well as assisting with absentee applications to help reduce misinformation among seniors.

The VEO Manager attended the Georgia Association of Registration and Elections Officials (GAVREO) conference to complete the mandatory training required each year to receive election updates for the 2025 year. The VEO team has begun reaching out to senior centers to assist with absentee ballot applications for the upcoming November General Election, as seniors will need to request ballots for each election. The VEO team continues to plan events and will keep reaching out to schools, community groups, nonprofits, and government officials to organize future activities across the county.
