FINANCE

DATE OF REPORT: 05/30/2025 PREPARATION FOR ELECTION / WORK SUMMARY:

The Fulton County Board of Commissioners (BOC) approved the 2025 Elections budget for a total of \$15 Million which included funding for the four upcoming PSC/Municipal elections. The approved 2025 Operating budget is \$5.4 Million.

The Financial Systems manager has continued to update the 2025 budget reporting. We are updating the funding needed for the team in preparation for each election cycle in 2025.

We are also processing the vendor invoices for expenses incurred for 2025 elections work.

We continue to review the budget to actual costs for the 2025 Election cycles. We are generating both the Accounting and Purchase order reports to review our costs and to stay within our budget.

We are continuing to track the costs incurred for the November 2024 general election, and the December 2024 municipal runoff election to review the budget to actual expenses. We have processed the last remaining vendor invoices from 2024, invoices submitted to Accounts Payable already for payment.

VOTER EDUCATION

DATE OF REPORT: May 31, 2025 PREPARATION FOR ELECTION / WORK SUMMARY:

In May, the Voter Education and Outreach team focused on promoting the General PSC Primary Election throughout the county, attending various events in different cities to ensure citizens were informed about the upcoming election. The VEO Manager also contacted all cities in Fulton County to ensure they were aware that early voting for the PSC race began in May and to gather information about city-wide events to provide educational opportunities.

The VEO Manager also provided a final Legislative update to the team for the bills that were signed by the Governor impacting the Elections Department.

Hb 296- Requires a physical copy of a driver's license for voting, effective upon the Governor's signature.

SB 199 - Removes county election offices from ethics filing. It goes into law on January 1, 2027, and allows elected officials to protect their information.

HHR 885- creates a study committee for election procedures, which will be abolished on December 1, 2025

The Following Bills were passed by one chamber and will be up for passage in 2026

<u>HB 397</u>

-Moves the departure of Georgia from ERIC to July of 2027 (by when, presumably, a new system will be in place)

-grants the SEB access to "communications between the Secretary of State and election superintendents" (i.e. Firefly)

-includes changes to rules for independent candidates for President

-includes video surveillance of drop boxes (if video surveillance is not practical, drop boxes can be moved and stored securely out of public areas)

-Both have restrictions on returning absentee ballots on Saturday or Sunday prior to the election, but place them differently in the code

- Includes changes to the daily 10:00 AM report for absentee ballots during early voting
- includes additional access for poll watchers at the tabulation center

- includes additional reports required before 11:59 PM (post unofficial SOVC)

<u>SB 214</u>

- voters allowed to request paper ballot in lieu of BMD ballot – would no longer use the Dominion machines

The VEO Manager also started drafting a calendar for the Special August 26th Senate District 21 Election, and the VEO team began reaching out to senior centers in District 21 to assist with Absentee Applications, as seniors will need to request an absentee ballot for each election. The VEO team has also sent materials to senior facilities, recreation centers, and libraries. The VEO manager has continued conducting Deputy Registrar Training for Staff and citizens.

The VEO team continuously plans events and will continue to contact schools, communities, non-profit organizations, and government officials to schedule future events throughout the county.
