## ADVANCE VOTING

**DATE OF REPORT:** 8.6.2025

### PREPARATION FOR ELECTION / WORK SUMMARY:

During July, we successfully conducted the **Public Service Commission Runoff Election**, with over 4,000 voters participating. The election proceeded smoothly, with no significant issues reported.

Following the conclusion of advance voting, our team carried out **post-election reconciliation** of Early Voting (EV) location operations to ensure full compliance with both county and state policies and procedures.

### ROUND TABLE DISCUSSION:

On **July 29, 2025**, we hosted a **post-election Zoom roundtable** titled "*Lessons Learned*" with EV managers and staff involved in the Public Service Commission Runoff Election. The session served as both an opportunity to thank the team for their dedication and to gather valuable feedback on their field experiences.

The discussion allowed EV managers to engage directly with the management team, sharing their observations, suggestions, and ideas for improving early voting training and overall field operations. This feedback is considered essential to our **continuous improvement efforts**, and we are committed to evaluating and implementing viable recommendations to enhance the early voting process.

Insights from the session are currently under review and will inform future improvements.

- Prepared for the upcoming **State Senate, District 21 Election**, including conducting review and training.
- Participated in multiple **budget meetings** to support planning for upcoming election events.
- Attended regular **weekly division meetings** to coordinate election activities.

## FINANCE

**DATE OF REPORT:** 08/04/2025

**PREPARATION FOR ELECTION / WORK SUMMARY:**

The Fulton County Board of Commissioners (BOC) approved the 2025 Elections budget for a total of \$15 Million which included funding for the four upcoming PSC/Municipal elections. The approved 2025 Operating budget is \$5.4 Million.

The Financial Systems manager has continued to update the 2025 budget reporting. We have updated the budgets for the July 15, 2025, PSC Primary run-off election. We have prepared a budget for the August 26, 2025, Special Called Election for State Senate 21 and for the possible Special Run-off Election on September 23, 2025.

We are also processing the vendor invoices for expenses incurred for 2025 elections work.

We continue to review the budget to actual costs for the 2025 Election cycles. We are generating both the Accounting and Purchase order reports to review our costs and to stay within our budget.

In July, the Information Systems division worked on the following items:

#### 1. July 15th Special Runoff Election

The Information Systems team completed all preparations and support activities for the July 15th Special Runoff Election. Key responsibilities included:

- Logic & Accuracy (L&A) Testing: Performed L&A testing and programmed all voting equipment for both Advance Voting and Election Day sites. L&A testing began on July 1<sup>st</sup>.
- Technical Support: Provided technical support throughout Advance Voting and on Election Day to ensure smooth operations at all polling locations.
- Election Night Operations: Closed out Advance Voting tabulators, uploaded memory cards from all precincts, tabulated results, and transmitted reports to the Secretary of State (SOS).
- Post-Election Activities: Received all voting equipment, completed final tabulation, and prepared official reports for election certification.

#### 2. Senate District 21 Special Election

System Specialists performed Logic & Accuracy testing for the Senate District 21 Special Election, provided technical support during Advance Voting, and coordinated planning for Election Day Training, Election Day support and tabulation.

#### 3. Election Infrastructure Security

The Information Systems division attended meetings and webinars organized by Microsoft and the Election Infrastructure Information Sharing and Analysis Center (EI-ISAC) to stay current on cybersecurity best practices and election infrastructure protection.

## VOTER EDUCATION

**DATE OF REPORT:** July 31, 2025

### PREPARATION FOR ELECTION / WORK SUMMARY:

In July, the Voter Education and Outreach team focused on promoting the General PSC Primary Runoff Election as well as the Senate District 21 Special Election throughout the county. They attended various events in different cities to ensure residents were informed about the upcoming elections. The VEO Manager also contacted all cities in Fulton County to confirm they were aware of the early voting dates in July, along with the Runoff Election date. Additionally, the Manager reached out to cities affected by the Senate District 21 election, and most of these cities featured the election information in their newsletters. The VEO Manager is staying informed and participating in all sessions of the Blue Ribbon Study Committee on elections to bring back updates about proposed legislation impacting elections next year to the Leadership team.

The VEO Manager conducted Deputy Registrar Training for Fulton County Administrators to keep them up to date on laws and election procedures for 2025, enabling them to host voter registration drives at their schools. The VEO team has been working to schedule events at Fulton County Libraries to provide election information to local residents. The VEO Manager also began meetings with college and university administrators to plan events and programs for when students return to campus. Follow-up was done on letters sent to each Fulton County college and university about third-party organizations registering students on campus, to ensure they partner with us and help reduce misinformation among students. The VEO team is collaborating with Atlanta Public Schools and Fulton County Schools to participate in open house and back-to-school events where voter education and registration support are needed. The VEO team has started reaching out to senior centers to assist with absentee ballot applications for the upcoming November General Election, as seniors will need to request ballots for each election. They have also sent informational materials to senior facilities, recreation centers, and libraries. The VEO Manager continues to conduct Deputy Registrar Training for staff and community members.

The VEO team continuously plans events and will keep contacting schools, community groups, nonprofits, and government officials to organize future activities across the county.
