

## Qualifying Period

Qualifying for political party, independent, and nonpartisan candidates will begin Monday, March 2, 2026, at 9:00 am – 4:00 pm and end on Friday, March 6, 2026, at 12:00 pm.

Nomination petitions for candidates qualifying as independent candidates are due to be submitted beginning at 9:00 am on Monday, June 22, 2026. The last day to submit a nomination petition is Tuesday, July 14, 2026, by noon.

Those who wish to qualify as a party candidate for Fulton County offices must do so with the Fulton County Democratic Party or the Fulton County Republican Party. For information

# QUALIFYING CHECKLIST



## Required Documents File Electronically

- **Declaration of Intent (DOI)** – file with Fulton County filing officer before accepting campaign funds.
- **Affidavit of Exemption Not To Exceed \$2,500** – file with Fulton County filing officer if the candidate does not plan to spend or receive over \$2,500.
- **Campaign Contribution Disclosure Report** – File with Fulton County filing officer if spending or receiving more than \$2,500 as listed in the filing schedule.
- **Personal Financial Disclosure Report** – due to the Fulton County filing officer within 15 days of qualifying.

- **Declaration of Candidacy and Affidavit**
- **Notice of Candidacy and Affidavit**
- **Valid Photo I.D.**
- **Payment:** Fees are paid to the organization with which the candidate qualifies
