

2023 ACTIVE OPEN ENROLLMENT

Welcome to Benefits Open Enrollment!

It's that time of the year again! Time to take a break from your busy schedule and review your County benefit options. Enrollment for medical/prescription drugs, dental, vision and life/AD&D insurance coverage will be **September 26 – October 14, 2022**.



Enrollment Is Required!

- Online enrollment is mandatory through the County's Employee Self Service (ESS) system: https://bit.ly/34mcmev
- o Enroll by October 14, 2022; otherwise, you and your current dependents will automatically be enrolled in the Kaiser HMO Plan for all of 2023. And, you won't have dental or vision coverage!
- o If you currently waive medical coverage but you're enrolled in the dental and vision plans, you must enroll through ESS to keep these plans.
- o If you currently waive medical, dental and vision coverage, your coverage will continue to be waived for 2023 if you don't enroll through the ESS system.

Important! Please ensure you have your 10-digit employee ID number to access ESS.

Changes You Can Make

During Open Enrollment, you can change your coverage for the plan year that starts January I, 2023, including electing coverage you don't currently have, declining coverage you have now, or changing your coverage tier (e.g., moving from Employee to Employee + I for medical coverage). After Open Enrollment, you can't change your 2023 coverage during the year unless you have an IRS-qualified life event (e.g., marriage, divorce, birth/adoption of a child).

Benefit Plans and Coverage Remain the Same for 2023

For 2023, you have the same four medical plan options as today:

- o Anthem Health Savings Account (HSA) Plan
- o Anthem Point of Service (POS) Plan
- o Anthem Health Maintenance Organization (HMO) Plan
- Kaiser Health Maintenance Organization (HMO) Plan

You also have two dental plan options:

o Aetna Dental PPO Plan

o Aetna Dental HMO Plan

You have one vision plan option: EyeMed Vision PPO Plan

In addition, you have **Basic Life and AD&D Insurance** and the option to choose **Supplemental Life Insurance and/or Dependent Life Insurance** coverage. The life and AD&D insurance plans are insured and administered by MetLife.

Open Enrollment Meetings

Again this year, Open Enrollment meetings will be held virtually through Zoom, a video conferencing platform. 2023 Health Care Premium Changes

Here's an overview of what's happening with your 2023 health care premiums (your cost to have coverage):

- o Anthem HSA Plan: increase of 4%
- o Anthem POS Plan: increase of 4%
- o Anthem HMO Plan: increase of 4%
- o Kaiser HMO Plan: increase of 5.4%
- Basic Life and AD&D/Supplemental Life: No changes
- o Aetna Dental PPO Plan: increase of 4.9%
- o Aetna Dental HMO: no changes
- EyeMed Vision PPO Plan: no changes
- o Dependent Life: increase to \$0.92 bi-weekly.







Don't lose out on your easy-to-earn/keep wellness credit!

Welcome to your wellness program! To earn/keep your \$240 annual wellness credit for plan year beginning 1/1/2023, eligible employees enrolled in medical coverage with Kaiser Permanente must complete the healthy activities* outlined below.

Here is how:

- 1. Visit kp.org/engage and sign on with your http://kp.org user ID and password
- 2. Accept the Wellness Program Agreement or you won't be eligible to earn rewards.
- 3. Be up to date with your biometric screening:
- Your non-fasting biometric screening includes: blood pressure, hemoglobin A1C, cholesterol and body mass index.
- If you are already scheduled for a physical, a biometric screening will be included.
- Or you can schedule a nurse visit appointment for biometric screening only by calling 404-365-0966.
- If you have a routine appointment already scheduled, please ask your doctor to include your biometric labs.
- 4. Attest to receiving the COVID vaccination. If you have already provided proof of vaccination to Fulton County, you will NOT be required to resubmit.

Eligible employees include current employees and new permanent employees hired by 9/14/2022. Return to the site as often as you would like to track your progress.

All activities must be completed by 12/31/2022.





2023 Voluntary Benefits Plan Options

Benefit	Vendor Partner	Description
Flexible Spending Accounts	Ameriflex	AFLAC Insurance handles the enrollment for flexible spending accounts (FSA) on behalf of Ameriflex, the County's third-party FSA administrator. The FSA program includes health spending, limited purpose spending, parking & transit reimbursement, and dependent care benefits.*Only permanent/full-time employees are eligible for this plan.
Critical Illness	Aflac	Under this plan, you select the amount of your benefit, up to \$20,000. There are no deductibles, and you'll receive a cash benefit even if you have medical coverage. This coverage is guarantee issue with no underwriting and includes an annual \$50 Wellness Benefit per insured per calendar year.
Hospital Indemnity	Aflac	This plan provides cash benefits for each day you are confined in a hospital for a covered illness or injury. The benefits help to safeguard against expenses that medical insurance may not cover.
Accident Insurance	Aflac	This plan covers a wide range of non-work injury- and accident-related expenses. Accident Plan benefits are paid to you in addition to any benefits you receive from your Fulton County medical plan, as applicable. You can use any doctor or facility, and there are no deductibles to meet or copays.
Whole Life	Aflac	This plan provides whole life insurance and opportunity to build savings through a cash accumulation account. You can take loans and partial withdrawals from the account (once the cash value builds). This benefit also includes an accelerated living death benefit that can be paid in a lump-sumor monthly over a period.
Short Term Disability	MetLife	This plan continues a portion of your income if you have a non-work-related illness or injury and cannot work. Benefits begin after an elimination period. The plan pays a percentage of your base pay up to a maximum with two coverage options.
Legal Plan	MetLife	MetLife's Legal Plan allows you to have a network of experienced attorneys at your fingertips to help when you need it. Get assistance with estate planning, home sales, tax audits and more.
Identity Theft	IDShield	Identity Theft protection provides a monitoring service that sends alerts at the first signs of fraud. The intelligence platform and monitoring capabilities detect, intercept, and restore the misuse of personal information that puts identities at risk.

Save Money in 2023

Avoid Paying an Extra \$50 a Month for Medical Coverage

If you enroll in medical coverage for 2023, you **must** complete the *Tobacco-Use Attestation* in ESS by **October 14, 2022**. If you don't, you'll pay a \$50 monthly tobacco-use surcharge by payroll deduction starting in January 2023. If you are a tobacco user and pledge during Open Enrollment to complete a tobacco cessation program, you must complete the program by **May 31, 2023** to receive a refund of the monthly surcharge. \$240 Annual Wellness Credit

New! In addition to scheduling a biometric screening and completing all the requirements, employees will need to provide proof they have received a designated COVID-19 vaccine. All active permanent employees enrolled in the County's medical coverage and all new employees hired through September 14, 2022 are required to complete ALL the required steps by December 31, 2022 to earn/keep their \$240 wellness credit.

Step-by-step instructions on how to complete the wellness credit requirements with your current medical carrier (Anthem or Kaiser) are included.
