ALL NEW BUSINESS APPLICANTS MUST APPLY IN PERSON

THESE INSTRUCTIONS ARE FOR BUSINESSES LOCATED IN THE <u>UNINCORPORATED AREA</u> OF FULTON COUNTY <u>ONLY</u> IN ADDITION TO THE APPLICATION THE FOLLOWING DOCUMENTS ARE REQUIRED:

REQUIREMENTS - COMMERCIAL BUSINESS

OWNER OR REPRESENTATIVE

FOR NEW APPLICATIONS & LATE RENEWALS MUST APPLY IN PERSON

- * (IF A REPRESENTATIVE FROM THE COMPANY IS APPLYING THE OWNER MUST PROVIDE THE REPRESENTATIVE WITH A NOTARIZED LETTER GIVING PERMISSION TO REPRESENT THE COMPANY.)
- * COPY OF THE **<u>SIGNED</u>** LEASE AGREEMENT or **<u>SIGNED</u>** PROPTERY/WARRANTY DEED

<u>PICTURE IDENTIFICATION</u> -- VALID DRIVER'S LICENSE/STATE IDENTIFICATION, CURRENT PASSPORT, OR PERMANENT RESIDENT CARD aka GREEN CARD (IF APPLICABLE)

COPY OF PERMITS OR CERTIFICATIONS:

REQUIREMENTS - HOMEBASED

- * **<u>PICTURE IDENTIFICATION</u>** -- VALID DRIVER'S LICENSE/STATE IDENTIFICATION, CURRENT PASSPORT, OR RESIDENCY CARD (IF APPLICABLE)
- * **PROOF OF RESIDENCY** (PROVIDE 1 OF THE FOLLOWING) -- SIGNED LEASE, PROPTERY/WARRANTY DEED OR UTILITY BILL (GAS, LIGHT OR WATER BILL)

FOR APPLICANTS WHO DO NOT HAVE PROOF OF RESIDENCY:

HOMEOWNER MUST PROVIDE AN ACCEPTABLE FORM OF PICTURE IDENTIFICATION, A COPY OF THE *UTILITY BILL IN THE HOME OWNERS NAME, and A NOTARIZED LETTER STATING THAT THE APPLICANT IS AN IMMEDIATE FAMLIY MEMBER THAT RESIDES AT THE HOME ADDRESS.
