- There is access to records from the last 20 years, but we need access to historical Fulton County records.
 - Commissioner Arrington: Requested information from <u>Denval Stewart</u> regarding
 where historical records are located. Fulton County has different departments with
 different records so narrow down request for specific time frames to help with

- Olivia Reneau, Research Fellow has access to records. Visited Vital Records for access and was referred to Georgia Archives for more information. Suggested talking to Dr. Paxton since Vital Records falls under the Board of Health. Confirmed Jennifer Collins is the attorney for the Board of Health in the County Attorney's office.
- 3. Fees waived for retrieving files

Dr. Karcheik Sims-Alvarado, Chair

- Provided examples of the types of records needed to complete annual report and gain relevant information. There are large gaps in service and records cost \$25 per file.
 - <u>Commissioner Arrington</u>: Send me all requests for records and I will send to Dr. Paxton so there will not be a fee.
- 4. January 2023 Board of Commissioners meeting regarding budget

Dr. Karcheik Sims-Alvarado, Chair

- Wanted to know where funding will come from to support any task force recommendations.
 Requested update on American Rescue Plan Act (ARPA) spending by Fulton County Government.
 - Commissioner Arrington: Fulton County has a \$1.3 billion budget per year so money for the task force should not be an issue. However, there needs to be a detailed plan on how the money will be spent. The 2023 budget will be passed at the next meeting on January 18 so will need to get budget information from the task force to make a motion on the floor as soon as possible. American Rescue Plan funding has restrictions on how it can be used so it is unlikely this will be a source.
 - O Denval Stewart: ARPA money should be used for pandemic related concerns. Would funds be used to continue research or to make reparations offers? Most task forces in the County are not funded. The establishing resolution for this task force does not include any plans for general, operational funding. Commissioner Arrington has been working on providing per diems or stipends for task forces, but this has not been approved by the full Board of Commissioners at this time.
 - <u>Dr. Karcheik Sims-Alvarado</u>: Funding would be used for both research and reparation payments.
 - Marcus Coleman, Vice Chair: Does not believe there is another task force who will be addressing recommendation on forms of reparations. As a result, this task force needs County funding to work efficiently, and we can send a budget request directly to <u>Commissioner Arrington</u>.

New Business

1. Research Update – Olivia Reneau and John Wright

Dr. Karcheik Sims-Alvarado, Chair

No additional updates since the last report due to holidays and car accident of Olivia. In the last report there was information on Bagley Park and other communities in the Buckhead area where people were displaced due to the County claiming eminent domain. Limitations to record access has impacted the next steps of research.

Elon Osby

- Confirmed park will be renamed Historic Bagley Park. <u>Buckhead Heritage</u> is responsible for paying for signage and currently accepting donations. \$13,000 is current amount needed towards a total \$40,000 invoice after site visit.
 - Commissioner Arrington requested invoice be forwarded for review, he will try to find money so please add it to the budget request. Suggested the Atlanta and Fulton County Recreation Authority might be able to underwrite costs.
- There has not been a date established for renaming the park at this time, but Mayor Andre Dickens might do a public announcement or a ceremony.
 - o Commissioner Arrington requested to be informed of ceremony date.

Marcus Coleman, Vice Chair

- Believes what happened in Bruce's Beach was a failure. The family sold the property back to Los Angeles County for \$20 million. Encouraged anyone who receives funding for reparations holds on to it. Believes there should be a financial literacy course to go along with any reparations provided by Fulton County.
- 2. Preparing for Annual Report (possibly March/April 2023)

Dr. Karcheik Sims-Alvarado, Chair

• Would like to provide report to the Board of Commissioners on what the task force has accomplished so far soon. The outline of the report is lengthy and shows how important access to records will be to continue research.

Marcus Coleman, Vice Chair

- Chairman Pitts made a replacement to the task force and we have not heard from her.
 - o <u>Tamika Jackson</u>: On board with research done so far and is interested in this topic. Requested guidance on how she can assist and contribute to task force goals.
- 3. Organizing Public Meetings by District

Dr. Karcheik Sims-Alvarado, Chair

- This is important work and not many people know we exist. Would like task force to serve as a blueprint for other counties to use. One proposal is for the first townhall meeting in February at Morehouse College to connect with young people and generate research allies. We want to hear from the public before making recommendations.
 - Commissioner Arrington recommended making a report at each Commissioner's district meetings. For example, he is already hosting regular townhall meetings.
 Welcomed the task force to present at an upcoming townhall.
- What is the protocol for organizing a meeting?
 - Denval Stewart: No protocols for the task force to organize a town hall, it would depend on participation. Suggested reaching out to nonprofits for funding.
 - o Fran Calhoun brought up the use of the County logo and requested legal clarity.
 - <u>Denval Stewart</u>: Only the Board of Commissioners can represent Fulton County. If the County is not the sponsor of the event, the County logo cannot be used.
 - o <u>Commissioner Arrington</u> suggested calling Morehouse to determine costs. Offered to host the meeting so please send the request for a flyer to his office.

Marcus Coleman, Vice Chair

- Agreed that selecting representatives from each school is a good idea, such as Student Government Association members. Would not feel comfortable making a report without public feedback. Mentioned the National Coalition of Blacks for Reparations in America (N'COBRA) is excited about the townhall.
- Would like to present to mayors of each city. Can task force be placed on agenda of an upcoming monthly Board of Commissioners and Mayors meeting? We could also invite all mayors to town halls.
 - Commissioner Arrington: Typically the Board of Commissioners meets with Mayors on the first Friday of each month but a 2023 meeting schedule has not been determined yet. Please inform when the task force would like to present.

4. Recommendations

Dr. Karcheik Sims-Alvarado, Chair

- How will we send the budget requests before the next Board of Commissioners meeting on January 18, 2023?
 - o <u>Commissioner Arrington</u>: Please submit all budget requests in writing. Each member should call their appointing member and request a favorable vote.
- Will send report and funding requests before January 18th
 - o <u>Commissioner Arrington</u>: The deadline to submit information is actually 10 a.m. on Friday, January 13th.
 - o <u>Denval Stewart</u>: Thursday, January 12th at noon would be better.
- Use research to help make people who experienced slavery and Jim Crow whole. Believes if all documents were in one place it would be very helpful. Therefore, one of her recommendations will be for a reparations focused facility located in the Historical District Development Corporation (HDDC) on Auburn Avenue. Fulton County could preserve the buildings and lease the property from HDDC. For example, it can be another branch of the library and show support for Alonzo Herndon who is a former slave.
 - Ommissioner Arrington: Not sure the task force is ready to make recommendations yet. Suggested engaging economists to help create a well-developed plan which should include associated costs before making recommendations. This will help justify why reparations are due and gain support for the recommended amount. Provided examples such as attorney Rodney Strong or an HBCU.
- Requested committee members provide examples of recommendations:
 - <u>Elon Osby</u>: Descendants of families who owned property in Fulton County that were displaced and lost property should receive reparations. The property value should be adjusted when making recommendation.
 - o Shanti Vissa: Clear ancestry is proven by anyone who receives reparations.
 - o <u>Marcus Coleman</u>: Monetary value of land with financial education included; Mental health and medical issues; Criminal Justice.
